ANNOUNCEMENT

The Central Board of Irrigation and Power (CBIP) in association with Central Electricity Authority (CEA) & India National Hydro Power Association (INHA) is organizing a National Conference on Preparedness on Disaster Prevention & Management for Hydro Power Projects on 23 January 2023 at Conference Hall of CBIP, New Delhi.

CONFERENCE OVERVIEW

India has been traditionally vulnerable to natural disasters on account of its unique geo-climatic conditions. Floods, droughts, cyclones, earthquakes and landslides have been recurrent phenomena. About 60% of the landmass is prone to earthquakes of various intensities; over 40 million hectares is prone to floods; about 8% of the total area is prone to cyclones and 68% of the area is susceptible to drought.

While dealing with these calamities, India has brought about a paradigm shift in the approach to disaster management. The new approach proceeds from the conviction that development cannot be sustainable unless disaster mitigation is built into the development process. Another corner stone of the approach is that mitigation has to be multi-disciplinary spanning across all sectors of development. The present policy also emanates from the belief that investments in mitigation are much more cost effective than expenditure on relief and rehabilitation. Disaster management occupies an important place in this country's policy framework as it is the poor and the under-privileged who are worst affected on account of calamities/disasters.

The approach has been translated into a National Disaster Framework [a roadmap] covering institutional mechanisms, disaster prevention strategy, early warning system, disaster mitigation, preparedness and response and human resource development. The expected inputs, areas of intervention and agencies to be involved at the National, State and district levels have been identified and listed in the roadmap. This roadmap is available with all the State Governments and Union Territory Administrations. Ministries and Departments of Government of India, and the State Governments/UT Administrations have developed their respective roadmaps taking the national roadmap as a broad guideline. Down the line, different hydro projects, have also identified probable disasters in their work area and developed action plans to meet out the calamities.

Though Disaster Management are the key areas where more attention is required to be given but unfortunately these areas are lacking behind and needs unified approach. CBIP, while appreciating the concern, has included these important areas in the ambit & scope of its training activities.

The objective of conference is to sensitize the Hydro Power Projects developers to share their experiences in dealing with crisis situations and steps/measures which could be adopted for such emergency conditions. A few case studies on various types of emergency situation giving details of action taken during and post crisis would be deliberated in the conference. Our endeavor is to develop one common format and monitoring procedure to forecast, take action and mitigate the distress.

In order to discuss and find solution to the various issues connected with the above subjects, the Central Board of Irrigation & Power in association with CEA & INHA is organizing this National Conference on Disaster Prevention and Management for hydro power projects on 23 January 2023 (Monday) at Conference Hall of CBIP, New Delhi
