Subject: Grant of onetime relaxation in calculating qualifying service of Seasonal Khalasi, CWC -regarding.

Sir,

I am directed to refer to All India Pensioner's Association, Central Water Commission's letter No. AIPA/CWC/2021-22 dated 27.09.2021 whereby it has been requested to grant one-time relaxation in the provisions of the Scheme of this Department for grant of temporary status and regularization of Seasonal Khalasis, Work Charge Establishment of Central Water Commission, so that 50% of the period of service rendered as Seasonal Khalasis (without Temporary Status) and 100% of the service rendered as Seasonal Khalasi, with Temporary status, may be taken into account in respect of the Seasonal Khalasis, for the purpose of calculating qualifying service for availing pension and other pensionary benefits, as per the CCS (Pension) Rules, 1972.

2. In this regard, you are requested to furnish details of all such Seasonal Khalasis who have superannuated before 2016 and who have been denied pension benefits under the provisions of CCS (Pension) Rules, 1972 for not having 10 years of qualifying service, **bringing out clearly the financial implication** if the said relaxation is acceded to.
