Sir,

I am directed to refer to the subject mentioned above and to say that 01 post of Storekeeper of Non-Ministerial Cadre of Subordinate Offices of CWC sanctioned for NEID-II, CWC, Aizawl under the Office of B&OBO, CWC, Shillong is lying vacant w.e.f. 01.07.2022.
