





Sir/Madam,

As you have been appointed Nodal Officer (Manpower) by your department and subsequent training on web based software i.e. "Polling Party Personnel Information Systems" had already been imparted by the office.

Now the URL <https://ceo.delhi.gov.in> has been placed under operational mode and you have been provided with **User ID and Password** to access the said URL for further verifying and uploading the details of officers/officials of your Department/Ministry etc. While verifying and uploading the manpower details, the Nodal Officer is required to ensure the following:-

1. that the office(s) set up in Delhi are only to be considered.
2. that the data shall also include the name of staff who are physically working in the organization such as on deputation, diverted capacity or else.
3. that 100% data of all the officer/official except Head of Department and following exempted categories shall be uploaded without any exemption:-
 - i. Uniform Personnel like Army, Navy, Air Force, CRPF, ITBP etc.;
 - ii. Contractual Staff;
 - iii. Outsourced Staff;
 - iv. Officers having grade pay more than Rs.8700=00 (In pre-revised pay scale).
 - v. Officers from educational services, technical services etc, whose pay structure is not identical with cadre staff, having grade pay more than Rs.10000=00 (in pre-revised pay scale).
 - vi. Officer/official already retired but is working on extension of service and on reemployment.

The Nodal Officer (Manpower) is further required to ensure that the entered data is complete and correct in all respect.
