Terms and Conditions

- 1. The late bids i.e. the bids received after the specified date and time for receipt of bids shall not be considered.
- 2. Rates shall be quoted "Per Unit" basis and shall include all charge related to transportation of material to site, i.e F.O.R at Kallooppara.
- 3. GST/Taxes, if any, shall be quoted separately failing which the quoted rates would be taken as inclusive of taxes and no subsequent request for addition of taxes would be entertained by this office
