- 1. Dte.) & CPIO, WP&P wing on transfer from Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide letter No A-49012/8/2021/RTI/365 dt 10/09/2021. also transferred this RTI application to Dir. & CPIO RMCD, CWC, New Delhi, SE (Coord) & CPIO Barak and other Basin organization, Shillong and SE (Coord) & CPIO Brahmaputra Basin Organization Guwahati under RTI Act 2005 of Central Water Commission.

- 3. While scrutinizing the correspondence made, it is found that the above RTI application was received in WP&P Coordination Dte. on 13/09/2021nd vide CPIO letter No I-12011/104/2021-WPP Coordination/ I/70816/2021 dt 14/09/2021 said RTI was further forwarded to Eco Directorate, RS Directorate, NP Directorate, Mon (E&W) Directorate and IP(N) Directorate for providing material for reply. The reply to the above said application was to be given by 13/10/2021 (by post & Email) i.e. within 30 days from the date of receipt of the application
  - 4. As per RTI Act, 2005, a citizen has a right to seek such information from a public authority which is held by the public authority or which is held under its control. It is important to note that only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The Public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants. Time limit for filing First Appeal as specified under section 19 & Section 19(1) of the RTI Act, 2005 is 30 days from the date on which information was received by the Applicant.
- 5. CPIO of WP&P Wing of CWC vide office letter No.I-12011/104/2021/WPP Coord/I/73180/2021 dated 07/10/2021 has sent all available information covering aspects such as National Projects Scheme, RRR of Water Bodies, PMKSY-AIBP and India-WRIS to the applicant by both post and email.
- 6. In light of above, the RTI Application CWCND/R/T/21/00100 dated 10/09/2021 under RTI Act 2005 of Shri V Ramesh Chandra Varma, which was received in WP&P Coordination Dte on 13/09/2021 is considered as settled under the provisions of Right to Information Act, 2005 and no further action on the part of CPIO, WP&P Wing of CWC is required.

**Decision:** In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant.

In the light of the above, the First Appeal No. CWCND/A/E/21/00036 dated 14/10/2021 Shri V Ramesh Chandra Varma is hereby disposed.
