- 3. While scrutinizing the correspondence made, it is found that the above RTI application was received in WP&P Coordination Dte. on 02/11/2021 and vide CPIO letter No I-12011/68/2021-WPP Coord.I/75573/2021 dt 08/11/2021 RTI was further forwarded to P&P Dte., Mon(S) Dte. and WM Dte. for providing material for reply. Additionally, RTI was also transferred to Director (D&R Coordination Dte.) & CPIO (D&R Wing) vide CPIO letter No I-12011/68/2021-WPP Coord.I/75572/2021 dt 08/11/2021. The reply to the above said application was to be given by 25/11/2021 i.e. within 30 days from the date of receipt of the application.
- **4.** As per RTI Act, 2005, a citizen has a right to seek such information from a public authority which is held by the public authority or which is held under its control. It is important to note that only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The Public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants. Time limit for filing First Appeal as specified under section 19 & Section 19(1) of the RTI Act, 2005 is 30 days from the date on which information was received by the Applicant.
- 5. On receipt of the nil information reply from P&P Dte, Mon(S).and WM Dte., CPIO of WP&P Wing of CWC vide this office letter No. I-12011/68/2021/WPP Coord/I/77052/2021 dated 25/11/2021 has informed the applicant that information sought by the applicant is not available in WP&P Wing of CWC and reply may be treated as nil as far as CPIO, WP&P wing of CWC is concerned. The said letter was sent to applicant vide email and post both.
- **6.** In light of above, the RTI Application no. CWCND/R/E/21/00233 dated 29/10/2021 which was received in WP&P Coordination Dte on 02/11/2021, shall be considered as settled under the provisions of Right to Information Act, 2005, with no further action on the part of CPIO, WP&P Wing required.

Decision: In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant.

In the light of the above, the First Appeal No. CWCND/A/E/21/00042 dated 30/11/2021 of Shri Dinesh is hereby dismissed.
