2. The RTI application having No CWCND/R/T/21/00086 dated 23/08/2021 was received in office of Director (WP&P Coord. Dte.) & CPIO (WP&P Wing) on transfer from Under Secretary and Nodal Officer, Right to Information, Central Water Commission, New Delhi, vide his letter No A-49012/8/2021/RTI/334 dt 24/08/2021. Officer, Right to Information also transferred this RTI application to SE (Coord) & CPIO, Narmada and Tapi Basin Organization, Gandhinagar under RTI Act 2005.

3. While scrutinizing the correspondence made, it is found that the above RTI application was received in WP&P Coordination Dte. on 25/08/2021 and vide CPIO letter No **I-12011/52/2021-WPP Coordination/ I/69146/2021** dt 01/09/2021 RTI application was further forwarded to Eco Directorate, PA (Central) Directorate and EM & EIA Directorate for providing material for reply. The reply to the above said application was to be given by 24/09/2021 (by post & Email) i.e. within 30 days from the date of receipt of the application
4. As per RTI Act, 2005, a citizen has a right to seek such information from a public authority which is held by the public authority or which is held under its control. It is important to note that only such information can be supplied under the Act which already exists and is held by the public authority or held under the control of the public authority. The Public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants. Time limit for filing First Appeal as specified under section 19 & Section 19(1) of the RTI Act, 2005 is 30 days from the date on which information was received by the Applicant.
5. CPIO, WP&P Wing of CWC vide office letter **No.I-12011/52/2021/WPP Coord/I/71517/2021** dated 21/09/2021 has sent reply to applicant's RTI by both post and email on 21/09/2021. However, as the annexure with the said letter contained a total of 23 pages, it was sent through email only. The applicant has confirmed receipt of same via email dated 25/10/2021. Hence, details/ information available in WP&P wing were provided to the applicant within permissible time period.
6. In light of above, the RTI Application CWCND/R/T/21/00086 dated 23/08/2021 under RTI Act 2005 of Ms. PANKTI JOG which was received in WP&P Coordination Dte on 25/08/2021 shall be considered as settled under the provisions of Right to Information Act, 2005 and no further action on the part of CPIO, WP&P Wing of CWC is required.

Decision: In view of the above, CPIO, WP&P Wing of CWC has acted in accordance to the provisions of RTI Act, 2005 and sent the reply at the earliest to the applicant.

In the light of the above, the First Appeal No. CWCND/A/E/21/00035 dated 14/10/2021 of Ms. Pankti Jog is hereby disposed.
