Water Resources Projects are planned, funded, executed and maintained by the State Governments themselves as per their own resources and priority. In order to supplement their efforts, Government of India provides technical and financial assistance to State Governments to encourage sustainable development and efficient management of water resources through various schemes

complete them in a time bound manner. Out of 99 projects and 7 phases (total -106), 53 MMI projects have been reported as completed as on date. The Ultimate Irrigation Potential of these 99 projects is 76.03 Lakh Ha., out of which 41.39 Lakh Ha. was created upto 31.03.2016. Out of balance 34.63 Lakh Ha, additional potential of 24.35 Lakh Ha has been created through these projects during 2016-2022.

Water being a State subject, steps for augmentation, conservation and efficient management of water resources are primarily undertaken by the respective State Governments. In order to supplement the efforts of the State Governments, Central Government provides technical and financial assistance to them through various schemes and programmes such as Repair, Renovation and Restoration (RRR) of Water Bodies / Surface Minor Irrigation Scheme as per guidelines of the scheme. Key objective of the scheme is Comprehensive improvement and restoration of water bodies, including protection works to avoid encroachment thereby increasing tank storage capacity. The other major objectives include Ground water recharge.

Further, as per information available, Gol launched Jal Shakti Abhiyan (JSA) during Nov, 2019 which is focused on accelerated implementation of five target interventions, viz., water conservation & rainwater harvesting, renovation of traditional and other water bodies/ tanks, reuse and recharge of bore wells, watershed development and intensive afforestation. This year also JSA has been undertaken, details in this regard may be available with National Water Mission (NWM).

Ministry of Agriculture and Farmers Welfare (MoA&FW) is funding the works related to On-farm ponds under Per Drop More Crop (PDMC) which also aim to conserve water. The details may be available with MoA&FW.
