After that he managed to get posted as Secretary CWC wherein he earned lakhs n lakhs of money in transfer postings along with holding charge of Vigilance Officer, CWC. It is known to everyone that when this Most-corrupt, but clean image officer transferred from PCP to Secretary CWC, charge/ additional charge of PCP Dte was not given to any director initially (when there are hundreds of officers at director rank available at HQ) due to the fear of losing money in pending bills, and therefore additional charge was given to a CSS officer in contravention of 70 years of prevalent norms, in connivance of Chairman CWC.
