2.	Provide me the details of the work done by ministry of water resources river development and Ganga	A. Currently, following two projects benefitting Jharkhand State are getting Central Assistance :

Central Assistance under PMKSY-AlBP. This project is proposed to provide irrigation to Culturable Command Area (CCA) of 1,51,323 ha (excluding CCA of 3479 ha of Chandil Right Main Canal) with Ultimate Irrigation Potential (UIP) of 2,29,323 ha under PMKSY-AlBP in East Singhbhum, West Singhbhum and Sareikela Kharsawan districts of Jharkhand.

2. North Koel Project: The project will provide irrigation benefit to 1,14,021 hectares of land annually in drought prone areas of Aurangabad and Gaya districts of Bihar and Palamau and Garwa districts of Jharkhand. It also has the provision for supply of 44 MCM water for drinking and industrial water supply.

The Cabinet Committee on Economic Affairs on 4th October, 2023, approved the proposal to complete the balance works of North Koel Reservoir Project at a revised Cost of Rs. 2430.76 crore (with central share of ₹1,836.41 crore) as against the balance cost of ₹1,622.27 crore (central share: ₹1,378.60 crore) approved earlier in August, 2017. A period of 30 month (upto 31.03.2026) has been provided for completion of balance works.

B. Details of projects of Jharkhand so far accepted in the meetings of the Advisory Committee of DoWR, RD & GR on Irrigation, Flood Control & Multipurpose Projects is enclosed as **Annexure-I**.
