With reference to above RTIs Application, which were transferred to this office from Under Secretary & Nodal Officer, RTI cell, CWC, New Delhi vide letter no. A-49012/8/2022/RTI/438 Dated 28/10/2022, A-49012/8/2022/RTI/447 Dated 02/11/2022 and A-49012/8/2022/RTI/452 Dated: 04/11/2022, the point wise information as available in WP&P Wing of CWC, is as under:

1.	What are the steps taken by central government in the year 2019-2022 to protect natural resources?	Government of India has launched multiple schemes to protect natural resources of the country. The scope of the schemes generally got enhanced based on the feedback received from the states. Many of these schemes continued during 2019-2022 also. Central Government facilitates implementation of the scheme by providing technical support and partial financial assistance as per the guidelines of the scheme. Out of the several schemes under execution on water resources, one of the schemes is Repair, Renovation and Restoration (RRR) of water bodies. State Governments are responsible for planning and implementation of the scheme.
2.	Any amendments made by central government for natural resources protection?	A pilot scheme was launched in January, 2005 for implementation during the remaining period of Xth Plan with an outlay of Rs. 300 crore. Subsequently, after launch of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2015-16, this scheme became part of Har Khet Ko Pani (HKKP) component of PMKSY. Government of India has approved the scheme of PMKSY with HKKP as one of the components, for implementation during 2021-26 with enhanced scope. Now in addition to water bodies directly linked to irrigation, other water bodies such as percolation tanks and the water bodies used for providing drinking water and for other community purposes which fulfil the eligibility criteria, are now proposed to be included under the scheme of RRR.
