The following certificate should also be recorded on the body of the bill.
 - i) Paid by me & materials received in correct and good condition.
 - ii) The bill has not been claimed before in any other shape.
 - iii) Rate is reasonable.
 - iv) I have neither claimed C.O.P. for the same item (Briefcase/ Bag) nor any briefcase / bag has been issued from any office of CWC during last 3 years reckoned from current date of purchase
- 3. The briefcase/ office bag / ladies purse shall be provided to the above officers/ officials on completion of three years from the date of issue of earlier one.
- 4. These orders are applicable to officers. Officials posted at CWC (H.Q.) as well as in field offices of CWC, with immediate effect.
