Please find enclosed a copy of MoWR, RD&GR OM dated 28.12.2017 on the subject cited above, wherein a reference has been made to the D.O. Letter dated 20.12.2017 of the Secretary, M/o Drinking Water and Sanitation expressing concern on the shortfall in the expenditure on SAP related activities against the targets set in respect of MoWR, RD & GR for FY: 2017-18 and to ensure utilization of 75% of funds allocated under SAP by 31.12.2017 and get the same uploaded on SAP portal.
