ORDER

In partial modification of this Commission's order of even number dated 21 February, 2023 in terms of provisions contained in Rule 39(2) of CCS(Leave) Rules, read with Ministry of Personnel, Public Grievances & Pension OM No.14028/3/2008-Estt(L) dated 25.09.2008, sanction of the competent authority is hereby accorded to the payment of Rs.12,38,750/- (Rupees Twelve lakh thirty eight thousand seven hundred fifty only) to Shri G.Satyanarayana, Assistant Executive Engineer, CWC who retired from Govt. Service on 31-12-2022 on attaining the age of superannuation, towards the amount of leave encashment equivalent to 281 days EL+ 19 days HPL as per rules.

At the time of retirement, his leave account has 281 days earned leaves and 310 days of HPL. His leave account has now been closed and no leave is to be debited from his account and not leave is to be sanctioned.
