1. The bids should be submitted in sealed cover/Envelope super-scribed "Bids for Disposal of old & unserviceable T&P articles of SE, HOC, CWC, Gandhinagar and Mahi Division, CWC, Gandhinagar due on 02/11/2017 time 3.00 PM".
2. The sealed bids should be dropped in the tender box placed in the office of the Executive Engineer, Mahi Division, CWC, 3rd Floor, Narmada Tapi Bhawan, Sector-10A, Gandhinagar on or before 02/11/2017 by 3.00 PM and will be opened on the same day at 3.30 PM in the office of the Executive Engineer, Mahi Division, CWC, 3rd Floor, Narmada Tapi Bhawan, Sector-10A, Gandhinagar. Intending bidders may be present at the time of opening of Bids.
3. The rates/ amount shall be quoted in figures & words separately for each item/ lot as mentioned in financial bid. Bids will be evaluated on consolidated rates. Item wise evaluation will not be done. Taxes & other levies, freight if any, will have to be borne by the bidder.
4. CWC will not entertain any claim for damage done by way of theft, pilferage, fire or any other unforeseen calamity after realizing full payment against the sale of unserviceable items.
5. Every bidder has to deposit Earnest Money Deposit (EMD) in cash/ Demand Draft in favour of EE, MD Gandhinagar amounting to Rs 900.00/- (Rupees nine hundred only), The cash should be deposited to the to the cashier of Mahi Division, CWC, Gandhinagar and the copy of the money receipt should be attached along with the quotation. In case of DD the DD should be attach with the quotation.

7. The auctioned items are to be lifted within 3 days of the issue of acceptance letter of offer on making full payment thereof; otherwise the earnest money deposited shall be forfeited.

13. All other rules and codes of CPWD and its amendment as applicable will be binding.




