
NOTICE INVITING SEALED QUOTATIONS

1. The quotations duly signed should be properly sealed and dropped in Quotation Box in the office or sent to this office of the Executive Engineer, Lower Godavari Division, 11-4-648, KG Bhavan, AC Guards, Hyderabad-500004. The sealed envelope should be super scribed "**Quotation for Disposal of Unserviceable T & P articles under O/o EE, Lower Godavari Division, CWC, Hyderabad**" due on **10/06/2019**
2. Undersigned will not entertain any claim for damage done by way of theft, pilferage, fire or any other unforeseen calamity after releasing full payment against the sale of auctioned vehicle.
3. Undersigned reserve the right to reject any or all the bids including the highest bid without assigning any reason.
4. All the material listed from SI No. 1 to 23 will be sold as **one lot**. The bidder is required to **quote his rate excluding applicable GST for the entire lot**. The applicable GST amount should be paid by the bidder to GST authority.
5. The exact amount in words as well as figures shall be mentioned in the quotation.
6. All the corrections/ over writing should be duly attested. Failing which the quotation will be disqualified.
