Please provide the information about the money spent on projects for water conservation in India till 2019	<p>1.Ministry of Jal Shakti (erstwhile Ministry of Water Resources, RD&GR), Government of India is implementing the Scheme “RRR of water bodies” which has multiple objectives like Comprehensive improvement and restoration of water bodies thereby increasing tank storage capacity, Ground Water Recharge, Increased availability of drinking water, Improvement in agriculture/horticulture productivity, Improvement of catchment areas of tank commands, Environmental benefits through improved water use efficiency; by promotion of conjunctive use of surface and ground water, Community participation and self-supporting system for sustainable management for each water body, Capacity Building of communities in better water management and Development of tourism, cultural activities, etc. The water bodies under the minor irrigation schemes which have a maximum CCA of 2000 ha (Rural water bodies) and satisfying the criteria of minimum 5 ha of water spread area in case of rural water bodies and 2-10 ha water spread area in case of urban water bodies are eligible to be included under the scheme RRR of water bodies. The above scheme is now part of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)- Har Khet ko pani (HKKP). So far, an amount of Rs. 380.93 crore has been released as Central Assistance(CA) to the States under the Scheme RRR of Water Bodies during XII Plan & onwards.</p> <p>2. 2	Copy of the approval given by the Central Water commission to the project	The project was put up before the Advisory Committee of DoWR, RD&GR on Major & Medium Irrigation, Flood Control and Multipurpose projects for consideration and acceptance in its 131st, meeting held on 16.11.2016 but the project was deferred due to non submission of statutory clearances along with other clarifications from the project proponent. The proposal was again discussed during 132nd meeting of Advisory committee of DoWR, RD&GR held on 06.03.2017. However, due to the same pending compliance on the part on the State Government, the proposal was again deferred for the next meeting. Later the project was put up on 133rd meeting of Advisory Committee held on 01.05.2017, project authority submitted compliance regarding pre and post rates for agricultural produce duly vetted by State Agricultural Department and has also submitted clearance from Ministry of Tribal Affairs of R&R plan of Tribal population. However, File No.I-12011/23/2019-PA(C) DTE Environmental clearance and Forest clearance of project was not submitted. In view of the above the project proposal again deferred to the next meeting of Advisory Committee. Later the project was discussed in 134th meeting of Advisory Committee held on 30.05.2017 but the project was deferred due to non submission of Environmental clearance and Forest clearance. After that, project was not put up before Advisory Committee of DoWR, RD&GR for acceptance.
