Agenda for VC to be taken by Chairman, CWC

TC Dte matters:

1. Delay in submission of VIP references: In many cases the VIP references require input from the State Government. Such VIP references are normally forwarded to the Regional Field office of CWC. It has been observed that such VIP references are pending for long. As replies to VIP references are to be given in time bound manner, it is requested that the Regional offices should take a proactive role in following up the matter with the State Government officials for timely reply of same.

WP&P wing matters:

3. Status of collection of data on irrigation potential created and utilized from various water resources projects like major, medium projects as well as ground water resources for each of the state/U.T.
