## कार्यालय आदेश

Sub.: Jurisdiction of BBO, CWC, Guwahati and B&OBO, CWC, Shillong

In continuation of earlier O.O. with respect to Jurisdiction of two field organization of CWC, namely BBO, CWC, Guwahati and B&OBO, CWC, Shillong following is further issued:

- 03 sites of Brahamaputra Basin in Meghalaya, namely, a) Myntangtihwieh (G Site) on River Myntangtihwieh b) Byrnihat (GQ Site) on River Umtru and c) Umroi (GD Site) on River Umiam shall continue to be handled/ operated by B&OBO, CWC, Shillong.
- 02 sites, namely, Umkhen-II (GDSQ) on River Umkhen and Umsiang (GDQ) on River Umsiang, located in Meghalaya and hitherto operated by MBD under BBO, CWC, Guwahati shall henceforth be handled/ operated by MID under B&OBO, CWC, Shillong.
- These 5 sites will be under the administrative control of BOBO, CWC, Shillong, however, technically these sites belongs to Brahmaputra basin. Therefore B&OBO, CWC, Shillong shall ensure timely uninterrupted supply of all data of these sites to MBD under BBO, CWC, Guwahati for utilization in FF activities and preparation of Year books.
- The data quality and also timeliness of data transmission has to be ensured by MID. As MBD will be user of the HO data observed and provided by MID, officials of BBO, Guwahati may also inspect these 5 sites on prior intimation to MID for improving data quality and site functioning.
