The undersigned is directed to refer to the following representations by Shri Dinesh Rajak, Shri K Nagaraja, Shri J K Chandravanshi, Sh. Ajit Kumar and Sh. B.B. Nayak, (all AD-II/SDE) dated 17.08.22, 23.08.22, 25.08.22, 18.08.22 and 22.08.22 respectively seeking grant of relaxation of upto 3 months as per DoPT's O.M. F. No. AB-14017/17/2018-ESTT.RR dated 12.08.2021 and to state that your representation(s) on the above mentioned matters had been forwarded to the cadre controlling authority i.e. DoWR, RD & GR, New Delhi for consideration and decision making.

The DoWR, RD & GR, New Delhi has after considering these representations stated vide Letter No. A-32012/12/2022-E-I Section - MoWR dated 21.09.2022 that the same have not been agreed to by the competent authority due to the reason that relaxation of 3 months on the basis of DoPT's 0.M dated 12.08.2021 (cp/26) is applicable to only those officers who are adversely affected by DoPT's O.M dated 08.05.2017, which is shifting the DPC procedure from Financial year to Calendar year. The DoPT has clarified that their O.M dated 12.08.2021 is not applicable in the case of CWES officers.

Accordingly, all representations submitted on seeking grant of relaxation of upto 3 months regarding promotions to the post of AD/AEE by the above mentioned officers along with a similar representation by Sh. D.A. Telangi, AD-II/SDE dated 18.08.2022 and by Sh. Punyashlok Baral dated 20.08.2022 are being treated as rejected and disposed of. Any other representation on similar matter(s) may also be treated as rejected and disposed of.
