OFFICE ORDER

Consequent upon inclusion of her name in the Select List of Private Secretary (PS) Grade of CSSS cadre, for the Select List year 2017 vide Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation Notification No. 77/2022 (File No. A.32012/5/2022-Admn) dated 22.07.2022, and Central Water Commission's Order No. A-32014/1/2021-Estt.IX/1/102059/2022 dated 25.07.2022, Smt. Sneha Lata Dheeman, Private Secretary (PS) is placed in the Non Functional Scale (NFS) pay matrix Level-10 w.e.f 01.07.2021 upon completion of 4 years of approved service in the grade of Private Secretary on 30.06.2021.

(*) She has not been given an increment on account of grant of NFSG as per para 3 of DoPT's OM No. 35034/3/2008-Estt.(D)(Voll.II) dated 04.07.2017 since she has already been given an increment while fixation of her pay at the time of grant of 3rd MACP w.e.f.01.07.2018.

3. The above pay-fixation is subject to post audit and in the light of audit observations over payment made if any, either in the form of arrears or otherwise, shall be recovered from the officer concerned in one lumpsum or otherwise, without notice.
