NOTICE INVITING QUOTATIONS

The Sealed quotations are invited for and on behalf of President of India for **Fabrication and supply of cubical Floor mounting type Changeover Switch Board in the regional office 'Sangamam' complex under the Southern Rivers Division, CWC, Coimbatore** as per the description of works and terms and conditions are given below.

TERMS AND CONDITIONS:

- Each bidder shall submit only one quotation. Normally, the lowest rates quotes will be accepted.
- Only those firms who are using good quality of materials as stipulated in the Indian standards and who will be able to execute the work within the stipulated time period need to quote the rates.
- The material shall be accepted only after due inspection by the office of CWC during Execution of work and before finishing. Usage of any substandard materials if noticed will make work liable to be rejected by CWC.
- Purchase Preference (Centre): Purchase preference to micro and small enterprises (MSE's) preference will be given to MSE's as defined in public procurement policy for micro and small enterprises (MSE's) ordered, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and medium enterprises and its subsequent orders/ Notification issued by consent Ministry. If the bidder wants avail the purchase preference, the bidder may be manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of public procurement policy for micro and small enterprises. In respect of bid for services, bidder must be service [provider of the offered service. In relevant documentary evidence in this regard shall be uploaded along with bid in respect of offered product or service. If L-1 is not an MSE and MSE sellers has/ have quoted price within L-1+15% of Margin of purchase preference / Price band defined in irrelevant policy, such seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 100% of total value.
- Purchase Preference (Centre): Preference to Make in India products (for bids less than 200 Crore). Preference shall be given to class I local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent orders/ Notifications issued concerned Nodal Ministry for specific Goods/ Product. The minimum local content to qualify as a class I local supplier is denoted in the bid document 50 percent. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rupees 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (Preference to Make in India) order 2017 dated 04.06.2020. Only class I and Class II local suppliers as per MII order 04.06.2020 will be eligible to bid. Non local suppliers as per MII order dated 04.06.2020 are not eligible to participate. In case buyer has selected purchase preference to micro and small enterprises clause in the bid, the same will be get precedence over the clause.
- Bids shall be accepted only offline.
- Quotation placed in a Sealed envelope, with the name of work, **Fabrication and supply of cubical Floor mounting type Changeover Switch Board in the regional office 'Sangamam' complex under the**

Southern Rivers Division, CWC, Coimbatore and due date written on the envelop will be received by the EE, SRD, Coimbatore up to 15:00 hrs on 22/07/2023 and will be opened by him or his authorized representative in his office on 22/07/2023 at 15:30 hrs.

8. The competent Authority for and on behalf of President of India, does not bind itself to accept the lowest or any other tender, and reserves its right to reject any or all of the tenders received or cancel the tendering process at any stage, either in part or full, without assigning any reason. All tenders, in whom any of the prescribed conditions are not fulfilled or are incomplete in any respect, are liable to be rejected.
9. The tender rates are valid up to 90 days only.
10. Rates must include all liabilities & GST where applicable to be quoted separately as applicable. No extra charges will be paid other than the rates approved.
11. Correction & over writing shall be duly attested.
12. The Successful Bidder needs to submit the Performance Guarantee (PG) @ 5% of bid amount. PG will be released after successful completion of the work.
13. Security Deposit @ 2.5% will be deducted from the running as well as final bill and the same will be released after Six month from the Successful completion of Work.
14. The work should be completed within **15 days** of the work order being placed. No time extension will be given for completion of work until and unless beyond control of human beings.
15. The Work will be inspected by the undersigned or his authorized representative of this department and get himself satisfied.
16. No advance payment will be made.
17. The Payment will be made only by PFMS/RTGS.
18. The Payment will be made on actual supply only.
19. Income tax and other taxes as applicable shall be deducted from the bill.
20. The Contractor must submit the PAN/TIN/Service Tax Number.
21. The restrictions on procurement from a bidder of a country, which shares land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with Competent Authority. While participating in bid, bidder has undertaken compliance of this and any falls declaration and noncompliance of this would be a ground for immediate termination of contract and further legal action in accordance with laws.
