**OFFICE ORDER**

In terms of Rule 50 & 51 of the Central Civil Services (Leave) Rules, 1972, **Shri Karthikeyan S.**, a Senior Time Scale officer of the Central Water Engineering (Group 'A') Service, working as Deputy Director, Design Standards Directorate, CWC, New Delhi, is granted Study Leave for 24 months from **01-08-2021 to 31-07-2023** for pursuing Post Graduate Degree Programme in "Dam Engineering", for the academic Session 2021, at Indian Institute of Science, Bangalore.

2. On completion of the Study, Shri Karthikeyan S., Deputy Director, CWC will submit to the Central Water Commission, the certificate of completion of course of study undertaken indicating the date of commencement and termination of the Study with remarks, if any, of the authority in charge of the Course of study. Shri Karthikeyan S. shall submit to the Government of India, on his return, a complete report on the course of study undertaken by him during his Study Leave.

If, Shri Karthikeyan S. resigns from Government Service or otherwise quit service without returning to duty after the period of Study Leave or within a period of three years after such return to duty or fails to complete the course of study for which the Study Leave has been sanctioned and is thus, unable to furnish the certificate as required under sub-rule (5) of Rule 53, he shall be required to refund, as provided under Rule 63(1) of CCS(Leave) Rules, 1972:

- i. the actual amount of leave salary, study allowance, travelling and other expenses, if any, incurred by the Government of India; and
- ii. the actual amount, if any, of the cost incurred by other agencies such as foreign Governments, Foundations and Trusts in connection with Course of study, together with interest thereon at the rates applicable for the time being in force on Government loans, from the date of demand before his resignation is accepted or permission to retire is granted or his quitting service otherwise.

4. Shri Karthikeyan S. is entitled to draw leave salary during the period of Study Leave in accordance with Rule 56(1) of the CCS(Leave) Rules, 1972.

5. He has executed Bond, Form-7 for Rs. 25,00,000/- (Rupees Twenty Five Lakhs only) and as prescribed vide DoPT O.M. No. 13026/4/2012-Estt(L) dated 18-2-2014 and same has been accepted by the Competent Authority in Central Water Commission.

6. The Study leave will not be debited against the leave account Shri Karthikeyan S., Deputy Director.

7. Shri Karthikeyan S., Deputy Director, Design Standards Directorate, CWC, New Delhi is also governed by the terms & conditions as enumerated in Training Directorate, CWC, New Delhi's Office Order No. A-33025/9/2021-TRNG dated 13-04-2021.

- i. the actual amount of leave salary, study allowance, traveling and other expenses, if any, incurred by the Government of India; and
- ii. the actual amount, if any, of the cost incurred by other agencies such as foreign Governments, Foundations and Trusts in connection with Course of study, together with interest thereon at the rates applicable for the time being in force on Government loans, from the date of demand before his resignation is accepted or permission to retire is granted or his quitting service otherwise.

4. Shri Roopesh D. is entitled to draw leave salary during the period of Study Leave in accordance with Rule 56(1) of the CCS(Leave) Rules, 1972.

5. He has executed Bond, Form-7 for Rs. 22,20,720/- (Rupees Twenty Two Lakhs Twenty Thousand Seven Hundred Twenty only) and as prescribed vide DoPT O.M. No. 13026/4/2012-Estt(L) dated 18-2-2014 and same has been accepted by the Competent Authority in Central Water Commission.


