ORDER

Pursuant to acceptance of recommendations of the Departmental Promotion Committee (Group-B) held for the vacancy year 2021, the Chairman, Central Water Commission hereby appoints Shri Sunil Negi, Junior Engineer in the Central Water Engineering (Group-B) Service on his promotion to the grade of Assistant Director Grade-II/Sub Divisional Engineer in the pay level 7 (Rs.44,900 - 1,42,400) on regular basis.

The promotion of the officer will be effective from the date he assumes charge in the higher post at the place indicated below and is directed to join at his respective place on promotion within 30 days from the date of issue of this order. No request or representation for modification in place of posting or to forgo the promotion shall be entertained after 30 days of the issue of this order.

5. The promotion of Shri Sunil Negi is subject to further orders that

may be passed by Hon'ble Supreme Court in the Civil Appeal No. 629 of 2022 arising out of SLP (C) No. 30621 of 2011 titled Shri Jarnail Singh & Ors Vs. Lachhmi Narain Gupta & Ors and other connected matters.
