

Terms and Conditions: -

1. The quotations duly signed should be properly sealed and either dropped in quotation box in the office of the Executive Engineer, Chenab Division, Central Water Commission, Jal Ayog Bhawan, Rajinder Nagar Phase-I, Bantalab, Jammu-181123 or to be sent by speed post/courier to this office.
2. The sealed envelope should be super scribed "Quotation for Shifting of Drilling Machines, Drilling accessories and other T&P items, Core Boxes etc."
3. In the event of the date of opening of quotation being a holiday, quotations will be opened on the next working day with timings unchanged.
4. The quotationer may inspect the material lying in the office of the undersigned during working hours i.e. 09:30 to 17:00 hrs from Monday to Saturday except second Saturday.
5. The quotationer should have valid PAN and GST Number.
6. The quotationer shall be required to deposit a sum of Rs 4000.00 (Rupees four thousand) only as Earnest Money Deposit in the form of Demand Draft of a scheduled bank issued in favour of Executive Engineer, Chenab Division, CWC, Jammu payable at Jammu. Quotations without Earnest Money Deposit will be summarily rejected.
7. Earnest Money Deposit will be forfeited if the agency not able to execute the work as mentioned in the schedule of quantities.

9. The rates are to be quoted F.O.R destination (from Chenab Division, CWC, Rajinder Nagar Phase-I, Bantalab, Jammu to CWC, Gulabgarh Camp Site in Kishtwar District, J&K) as per Schedule of Quantities mentioned under Annexure-I.
10. The approximate weight of material is 48 Tonne. The actual weight of material shall be finalized after weighing of all material (T&P and other items) at weighbridge by the transporter/carrier in presence of Engineer-in-Charge of material/items.
11. The approximate cost of the T&P and other items at present is Rs. 6,00,000.00 (Rupees six lakhs) only.
12. Responsibility for damage/theft/loss etc. of material/items during shifting and physical injury to labour during loading and unloading shall be of the firm/agency (Transporters/Carriers).
13. The quantum of cost associated with damage/theft/loss etc. of materials/items will be decided by the Engineer-in-charge of material/items and same would be collected from the selected agency/firm (Transporters/Carriers).
14. Responsibility of taking necessary permission from traffic police authority/local administration for shifting the material/items shall be of the selected firm/agency (Transporters/Carriers) without any additional cost/payment. Any charges in this regard shall be borne by the selected firm/agency (Transporters/Carriers).
15. Toll taxes, parking charges and other charges during transportation shall be borne by the selected agency/firm (Transporters/Carriers) without any implication of these charges in the final bill.
16. Rates of Service Tax/GST/Insurance should be mentioned as applicable.
17. The rates should be quoted both in figures as well as in words.
18. Rates quoted should be valid at least for 60 days from the date of opening of quotations.
19. The undersigned does not bind himself to accept the lowest quotation and reserve the right to accept or reject any or all the quotations without assigning any reason thereof.
20. All the correction and overwriting should be duly initialed.
21. Bill in duplicate may be submitted after satisfactory completion of work. The agency/firm (Transporter/carrier) shall prepare and submit the bill as per actual weight of material transported. The biller shall provide proofs of weighbridge's slips (Dharma Kanta) in this regard along with the bill/invoice.
22. The work should be completed as per specification within 20 days from the date of issue of work order.
23. No advance payment shall be made. Further, the payment shall be released only after the satisfactory completion of work.
24. The payment will be made through PFMS. For this, the quotationer must submit their Bank Account Details such as Account No., Name of the Account Holder, Name of the Bank and Branch, IFSC Code and address of the Branch. Copy of the cancelled check may be provided.
25. TDS including cess, as applicable will be deducted from the total bill amount.
26. The quotationer should follow the rules and terms & conditions of latest CPWD works manual.
27. In case of any dispute, the decision of The Executive Engineer, Chenab Division, CWC, Jammu shall be final and binding on all concerned.
