1. Item rate bids are invited up to 15:00 hours on 15.03.2023 on behalf of the President of India from registered, reputed, well established, and financially sound contractors for ***"Outsourcing of wooden Country boat for Hydrological observation at Sonapur Site (GDSQ) under MBD, CWC, Guwahati for the period of 3 years i.e., from 01/04/2023 to 31/03/2026."***

The enlistment of the contractors should be valid on the last date of submission of bids.

In case the last date of submission of bid is extended, the enlistment of contractor should be valid on the original date of submission of bids.

- 1.1 The work is estimated to cost Rs. 4,14,000/- (approx). This estimate, however, is given merely as a rough guide.

- 1.1.1 The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal with all matters relating to the invitation of bids.

For composite bid, besides indicating the combined estimated cost put to bid, should clearly indicate the estimated cost of each component separately. The eligibility of bidders will correspond to the combined estimated cost of different components put to bid.

- 1.2 Intending bidders is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below: -

Criteria of eligibility for submission of bid documents

- 1.2.1 Three similar works/associated works each of value not less than **Rs. 1,80,000/-** or two similar work each of value not less than **Rs. 2,70,000/-** or one similar work of value not less than **Rs. 3,60,000/-** in last 7 years ending previous day of last date of submission of bids.

Similar Works: Providing services of **Outsourcing of wooden Country boat for Hydrological observation at** in the past to Govt. Departments/PSUs.

To become eligible for the issue of bid, the bidders shall have to furnish an affidavit as under:
-

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in CWC in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid before the last date & time of submission of bids)

- 1.2.2 The contractors should have
 - a. MSME Registration certificate and turnover details.
 - b. Submit Turnover for the last two financial years.
 - c. PAN card of the firm.
 - d. submitted IT returns for the last two financial years
 - e. Contractor should have registration for Taxes/ GST
 - f. Work experience sought in this tender document.

2. Agreement shall be drawn with the successful bidders on prescribed Form No. **CPWD 7/8** (or other Standard Form as mentioned) which is available as a Govt. of India Publication and also available on website <https://eprocure.gov.in/eprocure/app> and <https://cwc.gov.in>. Bidders shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
3. The time allowed for carrying out the work will be **36 months approx.** from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the bid documents.
4. The site for the work is available.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with another necessary documents except Standard General Conditions of Contract Form can be seen on website <https://eprocure.gov.in/eprocure/app> and <https://cwc.gov.in>.
6. Earnest Money in the form of Treasury Challan or Demand Draft or Pay order or Banker's Cheque or Deposit at Call Receipt or Fixed Deposit Receipt (drawn in favour of Executive Engineer Middle Brahmaputra Division, CWC, Guwahati-781014) shall be scanned and uploaded to the e-Tendering website within the period of bid submission. Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Office of Executive Engineer, MBD, CWC, Guwahati within 5 days of Bid End date / Bid Opening date. The EMD receiving Executive Engineer (including NIT issuing EE/AE) shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by tender inviting EE in the NIT.
7. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
8. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
9. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted, then the bid submitted earlier shall become invalid.
11. The bid submitted shall become invalid if:
 - (i) The bidder is found ineligible.
 - (ii) The bidder does not deposit original EMD with division office of any Executive Engineer, CWC.
 - (iii) The bidder does not upload all the documents (including registration, Service tax registration/ GST registration/Sales Tax registration) as stipulated.
 - (iv) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted **physically by the lowest bidder** in the office of bid opening authority.

12. Performance Security

The successful bidder shall furnish performance security deposit at the rate of 3% of the contract value within 15 days after notification of the award and it should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier. Performance Security will be refunded to the supplier without any interest, whatsoever, after it duly performs and completes the contract in all respects but not later than 60 days of completion of all such obligations under the contract.

Performance security may be furnished in the form of account payee Demand Draft in favour of Executive Engineer, Middle Brahmaputra Division, CWC, Guwahati- 781014 payable at *Guwahati* or Fixed Deposit Receipt from a scheduled bank.

Performance security is liable to be forfeited in case successful tenderer does not fulfil contract obligations.

13. **The description of the work is as follows:**

Intending Bidders are advised to inspect and examine the site and its surroundings, scope of work and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as impracticable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site, scope of work whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

14. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

15. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.

16. The competent authority on behalf of the President of India reserves to herself/himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.

17. The contractor shall not be permitted to bid for works in the CWC Circle (Division in case of contractors of Horticulture/Nursery category) responsible for award and execution of contracts, in which his near relative is posted a Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Central Water Commission, Department or in the Ministry of Jal Shakti.

18. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.

19. ***The bid for the works shall remain open for acceptance for a period of Ninety (90) days from the date of opening of bids in case of single bid system.*** If any bidders withdraw his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work.

20. This notice inviting Bid shall form a part of the contract document. The successful bidders/contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of: -

CONDITIONS OF CONTRACT

Definitions:

1. The Contract means the documents forming the tender and acceptance thereof and the formal agreement executed between the competent authority on behalf of the President of India and the Contractor, together with the documents referred to therein including these conditions, the specifications, designs, drawings, Scope of work and instructions issued from time to time by the Engineer-in- Charge and all these documents taken together, shall be deemed to form one contract and shall be complementary to one another.
2. In the contract, the following expressions shall, unless the context otherwise requires, have the meanings, hereby respectively assigned to them:
 - i. The expression works or work shall, unless there be something either in the subject or context repugnant to such construction, Services, Scope of work etc be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted or additional.
 - ii. The Site shall mean the land/or other places on, into or through which work is to be executed under the contract or any adjacent land, path or street through which work is to be executed under the contract or any adjacent land, path or street which may be allotted or used for the purpose of carrying out the contract.
 - iii. The Contractor shall mean the individual, firm or company, whether incorporated or not, undertaking the works and shall include the legal personal representative of such individual or the persons composing such firm or company, or the successors of such firm or company and the permitted assignees of such individual, firm or company.
 - iv. The President means the President of India and her/his successors.
 - v. The Engineer-in-charge means the Engineer Officer who shall supervise and be in-charge of the work and who shall sign the contract on behalf of the President of India as mentioned in Schedule 'F' hereunder.
 - vi. Government or Government of India shall mean the President of India.
 - vii. The terms Director General includes Additional Director General and Chief Engineer of the Zone.
 - viii. Accepting Authority shall mean the authority mentioned in Schedule 'F'.
 - ix. Accepted Risk are risks due to riots (other than those on account of contractor's employees), war (whether declared or not) invasion, act of foreign enemies, hostilities, civil war, rebellion revolution, insurrection, military or usurped power, any acts of Government, damages from aircraft, acts of God, such as earthquake, lightening and unprecedented floods, and other causes over which the contractor has no control and accepted as such by the Accepting Authority or causes solely due to use or occupation by Government of the part of the works in respect of which a certificate of completion has been issued or a cause solely due to Government's faulty design of works.
 - x. Market Rate shall be the rate as decided by the Engineer-in-Charge on the basis of the cost of materials and labour at the site where the work is to be executed plus the percentage mentioned in Schedule 'F' to cover, all overheads and profits.
 - xi. Schedule(s) referred to in these conditions shall mean the relevant schedule(s) annexed to the tender papers or the standard Schedule of Rates of the government mentioned in Schedule 'F' hereunder, with the amendments thereto issued up to the date of receipt of the tender.
 - xii. Department means CWC or any department of Government of India which invites tenders on behalf of President of India as specified in schedule 'F'.
 - xiii. District Specifications means the specifications followed by the State Government in the area where the work is to be executed.

- xiv. Tendered value means the value of the entire work as stipulated in the letter of award.
 - xv. Date of commencement of work: The date of commencement of work shall be the date of start as specified in schedule 'F' or the first date of handing over of the site, whichever is later, in accordance with the phasing if any, as indicated in the tender document.
- 3. Where the context so requires, words imparting the singular only also include the plural and vice versa. Any reference to masculine gender shall whenever required include feminine gender and vice versa.
- 4. Headings and Marginal notes to these General Conditions of Contract shall not be deemed to form part thereof or be taken into consideration in the interpretation or construction thereof or of the contract.
- 5. The contractor shall be furnished, free of cost one certified copy of the contract documents except standard specifications, Schedule of Rates and such other printed and published documents, together with all drawings, Scope of work as may be forming part of the tender papers. None of these documents shall be used for any purpose other than that of this contract.
- 6. The work, services to be carried out under the Contract shall, except as otherwise provided in these conditions, include all labour, materials, tools, plants, equipment and transport which may be required in preparation of and for and in the full and entire execution and completion of the works/services. The descriptions given in the Schedule of Quantities (Schedule- A) shall, unless otherwise stated, be held to include wastage on materials, carriage and cartage, carrying and return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion of the work as aforesaid in accordance with good practice and recognized principles.
- 7. The Contractor shall be deemed to have satisfied himself before tendering as to the correctness and sufficiency of his tender for the works/services and of the rates and prices quoted in the Schedule of Quantities, which rates and prices shall, except as otherwise provided, cover all his obligations under the Contract and all matters and things necessary for the proper completion and maintenance of the works/services.
- 8. The several documents forming the Contract are to be taken as mutually explanatory of one another, detailed drawings, scope of work being followed in preference to small scale drawing and figured dimensions in preference to scale and special conditions in preference to General Conditions.
 - 8.1 In the case of discrepancy between the schedule of Quantities, the Specifications and/ or the Drawings, the following order of preference shall be observed:
 - i. Description of Schedule of Quantities.
 - ii. Particular Specification and Special Condition, if any.
 - iii. Drawings, Scope of work.
 - iv. CPWD Specifications.
 - v. Indian Standard Specifications of B.I.S.
 - 8.2 If there are varying or conflicting provisions made in any one document forming part of the contract, the Accepting Authority shall be the deciding authority with regard to the intention of the document and his decision shall be final and binding on the contractor.
 - 8.3 Any error in description, scope of work, quantity or rate in Schedule of Quantities or any omission there from shall not vitiate the Contract or release the Contractor from the execution of the whole or any part of the works comprised therein according to scope of work, drawings and specifications or from any of his obligations under the contract.
- 9. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of:
 - (i) The notice inviting tender, all the documents including scope of work, drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

- (ii) Standard C.P.W.D. Form as mentioned in Schedule 'F' consisting of:
 - a. Various standard clauses with corrections up to the date stipulated in Schedule 'F' along with annexure thereto.
 - b. C.P.W.D. Safety Code.
 - c. Model Rules for the protection of health, sanitary arrangements for workers employed by CWC or its contractors.
 - d. CPWD Contractor's and or CLC Labour Regulations.
 - e. List of Acts and omissions for which fines can be imposed.
 - (iii) No payment for the work done will be made unless contract is signed by the contractor.
10. Before submitting the tender, it is presumed that the tenderer has understood the exact requirement of the Purchaser and visited sites to understand the facilities and accessibility. In case of any discrepancy or ambiguity observed by the tenderer in the scope of work and the desired deliverable functionality from the work, it is mandatory to raise the clarification in writing well in time by the tenderer and in turn get that clarified from the purchaser in writing. In case of no such clarification required by the tenderer, it will be construed that all the requirements of the purchaser are understood by the tenderer. No communications will be entertained in this regard at any stage after the opening of Tenders.
 11. At any time prior to the deadline for submission of tenders, the Purchaser, for any reason, whether at its own initiative may modify the scope of work or any condition of the tendering documents by amendments.
 12. The tenderers must quote the rates keeping in mind all the terms and conditions mentioned in this document.
 13. The valid means of communications for this tender shall be in writing, through e-mail and fax followed by confirmation by post.
 14. No deviation in the payment terms mentioned above is permissible in the tender. If a tenderer does not explicitly agree with the payment terms mentioned above, the tender shall be rejected for non-responsiveness.
 15. The words 'bid' and 'bidding' has been used interchangeably with the words 'tender' and 'tendering' respectively.
 16. The words 'Tenderer' and 'Agency' has been used interchangeably.
 17. The Agency shall have permission to operate and work in *Assam, Meghalaya, and Tripura* by relevant government agencies.
 18. The Execution Period is the period during which the Contractor is liable to carry out work without any additional cost to the purchaser
 19. The Agency should not have been blacklisted by any authority. A declaration to the effect should be furnished;
 20. The Agency shall provide accurate information about any litigation or arbitration resulting from contracts completed or ongoing under its execution over the last Four years. A consistent history of awards against the Agency or any partner of a joint venture may result in failure of the contract.

INSTRUCTIONS TO BIDDERS FOR E - TENDERING THROUGH CPP PORTAL

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- 1) Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link “**Online bidder Enrolment**” on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats.

Bid documents may be scanned with 300 dpi with black and white option which helps in reducing size of the scanned document.

- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” or “Other Important Documents” area available to them to upload such documents. - 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document

SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR TENDERERS

1. The Executive Engineer, Middle Brahmaputra Division, Central Water Commission, Guwahati- 14, Assam invites the tenders from registered, reputed, well established and financially sound contractors for "Outsourcing of wooden Country boat for Hydrological observation at Sonapur Site (GDSQ) under MBD, CWC, Guwahati for the period of 3 years i.e. from 01/04/2023 to 31/03/2026"
2. The period of completion is **36 months approx.**
3. Details of works are provided in the Schedule of quantities.
4. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
5. Place of work will be at Sonapur site on river Digaru, District Kamrup Metropolitan, Assam.
6. Information and Instruction for bidders posted on website shall form part of bid document.
7. Tender Documents may be downloaded from CWC web site <https://cwc.gov.in> (for reference only) and CPPP site <https://eprocure.gov.in/eprocure/app> or can be issued from the office of Executive Engineer, Middle Brahmaputra Division, Central Water Commission, Guwahati as per the schedule given in Critical dates.
8. Bidder who has downloaded the tender shall not temper/ modify the tender form including downloaded price bid template at any manner. In case the same is found to be tempered/ modified in any manner, tender will be completely rejected.
9. Those contractors not registered on the website mentioned above, are required to get registered beforehand. Contractors are advised to follow the 'INSTRUCTIONS TO BIDDERS FOR e-TENDERING THROUGH CPP PORTAL' which is available with the tender document.
10. Bid shall be submitted Online only at CPPP website <https://eprocure.gov.in/eprocure/app>. Bid can only be submitted after uploading the mandatory scanned documents.
11. Intending bidders are advised to check CPP Portal/ CWC website for any Corrigendum/ Amendment.
12. The intending bidder must have valid class-III digital signature to submit the bid.

17. The proceeds of the performance guarantee shall be payable to the CWC as compensation for any loss resulting from the contractor's failure to complete its obligations under the contract.
18. The Performance guarantee deposit of the contractor shall be refunded after successful completion of the contract period provided there are no recoveries to be made arising out of poor performance and poor quality of work, incomplete work and / or violation of any terms and conditions of the contract as stipulated in the bid document. Refund of PG is subject to full and final settlement of the final payment for the work contracted / executed under the contract. No interest will be paid to the contractor on the PG.
19. The conditional bids shall not be considered and will be out rightly rejected in very first instance.
20. The competent authority of O/o Executive Engineer, Middle Brahmaputra Division, Central Water Commission, Guwahati-14, reserves the right to reject any or all bids without assigning any reason.
21. The Agency shall be responsible for safety, security and insurance including life insurance of their personnel who are deputed for driving the wooden boat. The Agency shall be fully responsible for observance of all labour laws applicable including local laws and other laws applicable in this matter and shall indemnify and keep indemnified CWC against effect of non-observance of any such laws. The Contractor shall be liable to make payment to all its employees, workers and sub-Contractors and make compliance with labour laws.
22. Prices quoted by the tenderer shall be fixed during the tenderer's performance of the Contract and not subject to variation on any account. The prices should be given as per the format given in price schedule/BOQ.

23. Non-conformities between the figures and words of the Quoted Prices – Sometimes, non-conformities/errors are also observed between the quoted prices in figures and that in words. The same is to be taken care of as indicated below:
- a) If, in the price structure quoted for the required goods, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
 - b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
 - c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.
24. Settlement of disputes-The settlement of all the disputes of any kind arising out of this contract shall be first through a Mediator engaged with mutual consent and only after dissatisfaction with that, the (joint) Arbitrator(s) shall be appointed as per Arbitration & Conciliation Act 1996.
25. Contractor's responsibilities and Obligations
- a. The Contractor will abide by the job safety, insurance, customs and immigration measures prevalent and laws in force and will be liable to indemnify the Purchaser from all demands or responsibilities arising from accidents or loss of life, the cause of which is the Contractor's negligence. The Contractor will pay all indemnities arising from such incidents and will not hold the Purchaser responsible in any manner.
 - b. The Contractor is responsible to conduct all contracted activities with due care and diligence, in accordance with the Contract and using state-of-the-art methods and economic principles, and exercising all reasonable means to achieve the performance specified in the Contract.
 - c. The Contractor is obliged to work closely with the Purchaser and abide by directives that are consistent with the terms of the Contract.
26. Purchaser's responsibilities
- a. The purchaser will ensure accuracy of all information.
 - b. The purchaser will ensure the availability of sites for the work.
 - c. The site for the work is available.
27. Duration of contract
- a. The period of operation of the contract shall be tentatively from April'2023 to March'2026. The duration of contract may be altered/ modified by the purchaser before awarding contract.
 - b. The contract may be extended up to 3 months at a time but not more than 6 months with mutual consents
28. This office shall not be liable for any financial or any other loss occur to bidder due to cancellation of tendering process at any stage by this office.

1. All services shall be performed by qualified and appropriate resource.
2. That the persons engaged shall not be below the age as per labour laws.
3. Payment will be made as per the actual use.
4. That the persons engaged shall not interfere with the duties of the employees of this office.
5. This office may require the service provider to dismiss or remove from the site of work, any person or persons, employed by the service provider, who may be incompetent or for his/ her/ their misconduct and the service provider shall forthwith comply with such requirements.
6. The Service provider shall replace immediately any of its personnel, if they are unacceptable to this office because of security risk, incompetence, conflict of interest and breach of confidentiality or improper conduct upon receiving written notice from office.
7. The service provider shall be contactable at all times and messages sent by phone /e-mail/fax/ special messenger from this office shall be acknowledged immediately on receipt on the same day. The Service Provider shall strictly observe the instructions issued by the office in fulfillment of the contract from time to time.
8. This office shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the personnel of the service provider.
9. The service provider shall be responsible for the safety and security of the HO instruments, computer hardware, other equipment provided by the department. If any equipment/ instruments, computer becomes non- functional/ damaged due to mishandling by the staff provided by the service provider, the charge for making the equipment, computers operational will be recovered from the agency. For this purpose, an indemnity bond has to be signed and furnished by the agency.
10. Escalation clause will not be accepted on any grounds during the period the contract is in force.
11. He services provider shall not assign, transfer, pledge or sub contract the performance of services without the prior written consent of this office.
12. **Penalty-**
 - a) Appropriate amount will be deducted from the payments due or performance security in case any loss is suffered by the department as per the contract.
 - b) In case the Wooden Country Boat will not available or remains absent, payments will not be paid for the absence of service. Further a penalty of Rs. 200/- per day would be imposed if contractor is not able to provide a replacement beyond 2 days.
 - c) In case the Contractor is unable to provide an alternate arrangement, the site-in-charge will have made such required arrangement and the cost have to bear by the Contractor. In addition, Performance Security may also forfeit.
13. **Loss of Property-**The Contractor shall indemnify and hold harmless the Purchaser and its employees from any losses, liabilities and costs resulting from the death, personal injury or loss to damage to the property, loss to the system arising due to the performance of contract.
14. **Terms of Payment**

The service provider will submit the bill in triplicate in respect of a particular month within 10th day of the succeeding month. The payment will be released after submission of claim, complete in all respects such as dated Acquaintance roll, certificate given by the Officer In-Charge regarding discharge observation on full month. Office will not be responsible for delay in processing the bill without proper document.

 - a. Deduction of tax at source (TDS) as per applicable rates prescribed under the Income- tax Act, 1961, shall be made by the Executive Engineer, Middle Brahmaputra Division, CWC, Guwahati- 781014 from every payment made under this contract.
 - b. Payment of GST shall be on reimbursement basis on production of proof of payment.
 - e. Payments to the service provider would be strictly on the basis of certification by the officer with whom the personnel is attached that his services are satisfactory as per the bill preferred by the service provider.
15. **Termination of Contract**

For Purchaser's convenience-

The Purchaser can terminate the contract at any time by giving a notice of 15 days to the Contractor. The Contractor shall have no claim to any payment for the compensation or otherwise whatsoever on account of any profit or advantage which might have been derived.

For Contractor's Default-

The Purchaser without prejudice to any other rights or remedies it may possess may terminate the contract

If the Contractor becomes bankrupt or insolvent

If the Contractor has abandoned or repudiated the contract, persistently failed to carry out its obligations under this contract.

If the Contractor neglects its obligations under this contract.

If the contractor has furnished any false document.

The Purchaser may without prejudice to any other right issue a notice for termination of the contract stating the nature of default and requiring the remedy for the same. Failure of the Contractor to carry out a specified work may be sufficient grounds for termination of the contract by the purchaser.

Termination by Contractor-

The Contractor can terminate the contract with 30 days' notice only in case:

The Contractor is unable to carry out its obligations of the contract for any reason attributable to the Purchaser.

If the agency fails to give one month's notice in writing for termination of the Agreement, then one month's wages etc and any amount due to the Service Provider from the office shall be forfeited.

On every termination- The Contractor shall cease further work. Under such circumstance, only the contract price properly attributable to the part of the work duly valued by the Purchaser shall be payable by the Purchaser to the Contractor. The decision of the purchaser shall be final in this respect.

16. **Liquidated Damages**-If this office suffers any loss or damage on account of negligence, default or theft on the part of the employees/agents of the agency, then the agency shall be liable to reimburse to this office for the same.

The agency shall keep this office fully indemnified against the damage by any staff engaged by the Agency.

For any accident or casualty occurred during the course of working to any staff deployed by the Agency, the liability that will arise out of the accident will be borne by the Agency. The responsibility will remain with the Agency and this office will in no way be responsible for it or any other clause mentioned above.

Notwithstanding the provisions of tender document, the Contractor shall not be liable for liquidated damages, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

17. **Notices**-Notwithstanding anything stated otherwise, all notices of this contract shall be in writing through registered mail, speed post, personal or courier deliveries. The transmission by electronic data exchange (fax, email) shall be reconfirmed in writing. Any change in the address etc. shall be communicated within 10 days to other party.

18. **Disputes**-The decision of the Purchaser shall be final regarding the quality of services provided by the manpower provided by the agency, the other aspects arising shall only be referred as Disputes. The Contractor may address its intention with evidences for the settlement of dispute in writing to the Purchaser. The work shall not stop, unless agreed mutually or ordered by the arbitrator(s).

19. **Settlement of Disputes**-The settlement of all the disputes of any kind arising out of this contract shall be first through a Mediator and only after dissatisfaction with that, the (joint) Arbitrator(s) shall be appointed as per Arbitration & Conciliation Act 1996.
