Chapter 1. Instructions to Bidders

1. General

Before submitting the tender it is presumed that the tenderer has understood the exact requirement of the Purchaser and visited hydrological observation Nalas/Streams/Rivers run by Central Water Commission to understand the facilities and accessibility. In case of any discrepancy or ambiguity observed by the tenderer in the scope of work and the desired deliverable functionality from the work, it is mandatory to raise the clarification in writing by the tenderer and in turn get that clarified from the purchaser in writing before and during the pre-bid meeting. Tenderer is free to ask any clarification (which should reach this office atleast two days before the date of pre bid meeting in writing by email/Fax or speed post) in the Pre-bid meeting to be held on 10.04.2018, 15:00hrs at above mentioned venue. In case of no such clarification required by the tenderer, it will be construed that all the requirements of the purchaser are understood by the tenderer.

The general instructions are as given below:-

- (i) No tenderer will be allowed to amend or withdraw any terms & conditions/parts or whole /quoted prices of its tender under any circumstances after the deadline for submission of the tender.
- (ii) The Purchaser has the right to accept or reject any or all the tenders, or cancel the tendering process at any stage, either in part or full, without assigning any reason.
- (iii) Canvassing, soliciting, fraud practices, suppression of facts, stating wrong facts and fraudulent practice by the tenderer may lead to rejection of the tender at any stage of the work and may lead to blacklisting for all future CWC works/purchases.
- (iv) The tenderers are expected to understand the forms, terms, specifications and other details mentioned in the tender document.
- (v) Each tenderer is entitled to submit only one online bid under his digital signature certificate. The tender document is nontransferable.
- (vi) At any time prior to the deadline for submission of tenders, the Purchaser, for any reason, whether at its own initiative may modify the scope of work or any condition of the tendering documents by amendments and same will be communicated.
- (vii) The tenderers must quote the rates keeping in mind all the terms and conditions mentioned in this document.
- (viii) The valid means of communications for this tender shall be in writing, through e-mail and fax followed by confirmation by post.
- (ix) It is suggested that the tenderers may acquaint themselves with the requirements of the work before submitting the tender. Tenderer should visit the different sites before submission of bid.

- (x) No deviation in the payment terms is permissible in the tender. If a tenderer does not explicitly agree with the payment terms, the tender shall be rejected for non-responsiveness.
- (xi) The words 'bid' and 'bidding' has been used interchangeably with the words 'tender' and 'tendering' respectively.
- (xii) The words 'Tenderer' and 'Agency' has been used interchangeably.
- (xiii) Bids shall be submitted online only at TCIL website URL https://www.tcil-india-electronictender.com.Tenderer/Agency are advised to follow the instructions provided in the 'Instructions to the Agency/Tenderer for the e-submission of the bids online through TCIL portal. The tender notice is also available at www.tcil-india-electronictender.com.Tenderer/Agency are advised to follow the instructions of the bids online through TCIL portal. - (xiv) Tenderer who has downloaded the tender from the TCIL website URL https://www.tcil-india-electronictender.com, Central Public Procurement Portal (CPPP) website https://eprocure.gov.in and www.cwc.nic.inshall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and EMD would be forfeited.
- (xv) Intending tenderers are advised to visit again TCIL website URL https://ender.com, CWC website www.cwc.gov.in and CPPP website https://eprocure.gov.in at least 1 day prior to closing date of submission of tender for any corrigendum / amendment.
- (xvi) For the purpose of this tender the Contract Agreement with the successful tenderer shall comprise of:
 - a. The technical bid and financial bid submitted by the tenderer online;
 - b. Tender document
 - c. Amendment to the tender document;
 - d. Post tender opening Correspondences both online and offline; and
 - e. Purchaser's notification of award of the contract.

2. SUBMISSION OF DOCUMENTS

- (i) The following documents are to be furnished online in the technical bid part by the Agency along with bid as per the tender document:
 - a. Signed and scanned copy of valid registration certificate for supply of manpower issued by Central/State Govt., PAN and Tender Acceptance Letter (Form 3 chapter 7).
 - b. Signed and scanned copy of experience certificates of similar works." Similar works means supply of man power".
 - c. Signed and scanned copy of Income-tax return filed for previous three Financial Years (2014-15, 2015-16, 2016-17), GST No., Affidavit of partnership firm or Pvt. Ltd. or public Ltd. company registered certificate.

- d. Signed and scanned copy of audited Balance sheet of last three Financial Years (2014-15, 2015-16, 2016-17).
- e. Self-certified declaration of not been blacklisted by any Central/State Govt./PSU.
- f. Any other document in manpower of the Bid.
- (ii) The following documents are to be furnished **online in the financial bid** part by the Agency:
 - a. Technical and Financial Bids as defined in Chapter-5 of tender document.
- (iii) Before opening of tender, the Agency/Tenderer are required to furnish following at the office of EE, Planning & Investigation Division, Faridabad.
 - a. Cost of the tender amounting to Rs. 1000/-
 - b. EMD of Rs. 1,78,000/-(Rupees One Lakh Seventy Eight Thousand) only
 - c. Pass-phrase for opening of Technical and Financial Bids. Passphrase shall be supplied in one big sealed envelope containing two small sealed envelopes having pass-phrase for technical & financial bids. Each envelope shall be clearly marked "pass-phrase for technical bid" and "pass-phrase for financial bid". Bigger envelope shall be marked as "pass-phrases for Tender for "Providing Manpower Services for Hydrological Observations on Nalas/Streams/Rivers in East and West Singhbhum District, Jharkhand".

3. Qualification/Eligibility Criteria for the Tenderers:

- i). The Agency should be registered in India with permanent office in India.
- ii). The Agency shall have permission to operate and work in Jharkhand by relevant government agencies.
- iii). The bidder should have GST No./PAN/Aadhaar No.
- iv). Joint Ventures (JV) shall submit its full details;
- v). The Agency should not have been blacklisted by any authority. A declaration to the effect should be furnished:
- vi). The Agency shall provide accurate information about any litigation or arbitration resulting from contracts completed or ongoing under its execution over the last five years. A consistent history of awards against the Agency or any partner of a joint venture may result in failure of the contract.
- vii). Contractors whose near relatives are Divisional Accountant or Engineering Officers between the grades of Chief Engineer and Junior Engineer (both inclusive) in the Central Water Commission (CWC) will not be allowed to tender for works in the respective Regional office responsible for award and execution of contract is the one where the near relative is working. For this purpose, a near relative shall mean father, mother, wife/husband, son(s), daughter(s), brother(s), sister(s).

- viii). No Engineer or any other official employed in Engineering or Administrative duties in the Engineering Department of the Government of India is allowed to work in the CWC either as contractor or as employee of a contractor for a period of one year after his retirement from Government service unless he has obtained prior permission of Government of India to do so. Even after enlistment, if either the contractor or any of his employees is found to be a person who had not obtained the prior permission of Government of India as aforesaid, the Contract shall be cancelled.
- ix). Average Annual financial turnover of related services in Central/ State Govt./ PSU during the last three years, ending 31stMarch 2017, should be at least Rs 1 crore. Relevant work orders issued by Central/ State Govt./ PSU along with satisfactory performance certificates have to be enclosed.
- x). Liquid assets and/or credit facilities, net of other contractual commitments and exclusive of any advance payments which may be made under the contract, of no less than the amount specified in the Bid Data Sheet (BDS).

4. Qualification Documents to be submitted:

- i). Copies of original registration certificate documents defining the constitution or legal status, place of registration and principal place of business; written power of attorney of the signatory of the bid to commit the bidder. Appropriate business licences/registrations:
 - a) GST No.;
 - b) PAN number;
- ii). Total monetary value of services performed for each of the last three years;
- iii). Copies of work orders issued by Central/ State Govt./ PSU along with satisfactory performance certificates in related work for each of the last three years and details of services under way or contractually committed; and names and address of clients who may be contacted for further information on those contracts
- iv). Evidence of adequacy of working capital for this contract (access to line(s) of credit and availability of other financial resources);
- v). Audited financial statements for the last three financial years 2014-15, 2015-16 & 2016-17(copies of the Profit and Loss (P/L) statements along with Balance Sheet for the concerned period);
- vi). Bank Account details;
- vii). Authority to seek references from the bidder's bankers;
- viii). The Agency shall provide accurate information about any litigation or arbitration resulting from contracts completed or ongoing under its execution over the last five years. A consistent history of awards against the Agency or any partner of a joint venture may result in failure of the contract.

5. Site Visit:

The bidder, at the bidder's own responsibility is encouraged to visit at their own cost and examine the site of required services and its surroundings and obtain all information that may be necessary for preparing the bid and entering into a contract for the services.

6. Period of validity of tenders

Tenders shall remain valid for **90(ninety) days** after the date of tender opening. In exceptional circumstances, the purchaser may solicit the tenderer's consent to an extension of the period of validity. The request and the responses thereto shall be made in writing. The tender security provided shall also be suitably extended. Tenderer may refuse the request without forfeiting its EMD.

7. Restrictions regarding Personnel Deployed:

The Agency shall be liable for all kinds of dues payable in respect of all personnel provided for manpower services under the contract and the Procuring Entity shall not be liable for any dues for availing the manpower services of the personnel. The Agency shall ensure that a valid identity proof of personnel deployed is submitted to CWC (such as Passport/PAN Card/Aadhar Card/Election Card/Ration Card/Driving License etc).

8. Workmen Safety and Insurance:

The Agency shall be responsible for safety, security and insurance including life insurance of their personnel who are deputed for providing manpower services for hydrological observation. The Agency shall be fully responsible for observance of all labour laws applicable including local laws and other laws applicable in this matter and shall indemnify and keep indemnified CWC against effect of non-observance of any such laws. The Contractor shall be liable to make payment to all its employees, workers and sub-Contractors and make compliance with labour laws.

9. Filling up the Technical and Financial Bid by the Bidders:

The Bidder should fill Technical and Financial bids both as described in Chapter 5. In the financial bids as per activity schedule described in chapter 3, the Agency should quote for all locations of H.O sites. GST should be shown separately in the financial bid.

10. Tender Security and Performance Security

i. Earnest Money Deposit (EMD):-

EMD shall be deposited in the form of Crossed Demand Draft in favour of Executive Engineer, Planning & Investigation Division, CWC payable at Faridabad or in the form of a Bank Guarantee from a scheduled bank as per Performa given in Chapter 7. In case the EMD is submitted in the form of the Bank Guarantee it shall remain valid **up to 45 days** beyond the final tender validity period. The tenders unaccompanied by the Tender Security/EMD will be rejected summarily.

The EMD shall be forfeited if:

- a. If a tenderer withdraws its tender during the period of tender validity specified by the tenderer; or
- b. In case of a successful tenderer, if the tenderer fails:
 - (i) To sign the Contract within 07 days of the issue of the notification for award of the contract; or
 - (ii) To furnish the specified performance security.
- c. Government Departments and Public Undertakings are exempted from furnishing EMD.

Refund of EMD

EMD furnished by all unsuccessful tenderers will be returned to them without any interest whatsoever, at the earliest after expiry of the final tender validity period but not later than 30 days after signing of contract by successful tenderer. EMD of the successful tenderer should be returned, without any interest whatsoever after receipt of performance security.

ii. Performance Security

The successful bidder shall furnish performance security deposit at the rate of 5% of the contract value within 07days after notification of the award and it should remain valid for a period of 60 days beyond the date of completion of all contractual obligations of the supplier. Performance Security will be refunded to the supplier without any interest, whatsoever, after it duly performs and completes the contract in all respects but not later than 60 days of completion of all such obligations under the contract.

Performance security may be furnished in the form of account payee Demand Draft in favour of Executive Engineer, Planning & Investigation Division, CWC payable at Faridabad or Fixed Deposit Receipt from a commercial bank or Bank Guarantee from commercial bank in a prescribed format as given in chapter 7 form 2.

Performance security is liable to be forfeited incase successful tenderer does not fulfill contract obligations.

11. Contents of Tender Document:

The contents of the tendering documents as listed below shall be read in conjunction with any corrigendum/addenda, if issued. All the components of the tender shall be considered as a single tender document and include:

- (i) Notice Inviting e-Tender
- (ii) Instructions to the Tenderers
- (iii) Conditions of the Contract
- (iv) Schedule of requirement.
- (v) Specifications and allied technical details.
- (vi) Price schedule
- (vii) Contract Form

- (viii) Other standard forms
- (ix) Performance Security Forms/Bid Security (EMD).

12. Tendering Process

i. Marking and submission of tenders:

Proposals must be submitted online only at TCIL website URL https://www.tcil-india-electronictender.com by 23.04.2018up to 17:00 hrs. Tenderer/Contractor is advised to follow the instructions provided in the 'Instructions to the Contractor/Tenderer for the esubmission of the bids online through TCIL portal.

The tenderers should submit both "**Technical bid**" and "Financial Bid" online. The EMD along with tender fee must reach office of Executive Engineer before date and time of opening of online bid. Tenders of bidder whose EMD and tender fee does not reach in time will not be opened online and will be archived.

Tenders must be submitted by the bidder online no later than the time and date specified in the NIT.

Intending tenderers are advised to visit again TCIL website URL https://www.tcil-india-electronictender.com, CWC website www.cwc.nic.in and CPPP website https://eprocure.gov.in at least 1 day prior to closing date of submission of tender for any corrigendum /amendment.

The Purchaser may, at its discretion, extend this deadline for submission of tenders by amending the tendering documents, in which case all rights and obligations of the Purchaser and tenderers previously subjected to the dead line will thereafter be subjected to the deadline as extended.

In the event of the date being declared as a closed holiday for purchaser's office, the due date for submission of tender and opening will be carried out on the date and time as notified by the purchaser. The necessary corrigendum shall be issued in this regard by the purchaser.

No tender may be withdrawn in the interval between the deadline for submission of tenders and the expiration of the period of tender validity specified by the tenderer on the Tender Form. Withdrawal of a tender during this interval may result in the tenderer's forfeiture of its tender security(EMD).

ii. Opening of Bids:

The bids shall be opened online on the date and time mentioned in the NIT. Tenders unaccompanied by the Tender Security (EMD) and tender fee shall be archived and will not be opened.

Financial Bids of only those bidders who are found technically acceptable would be considered.

iii. Prices

Prices quoted by the tenderer shall be fixed during the contract. Rates to be quoted by the tenderer should be all inclusive. GST should be quoted separately.

- **a.** All prices should be in Indian National Rupee (INR).
- **b.** The amount should be written both in figures and in words.
- **c.** Prices for each item shall be furnished as per price schedule.
- **d.** The tenderer should quote for all the service manpower at all the sites mentioned in the schedule of requirement. The tenders not quoting for all the services at all the sites shall be rejected.
- **e.** The tender for the service manpower shall remain open for acceptance for a period of **90** (**ninety**) **days** from the date of opening of tenders. If any tenderer withdraws his tender before the said period or makes any modifications in the terms and conditions of the tender which are not acceptable to government, then the Government shall without prejudice to any other right or remedy, be at liberty to forfeit earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering process of the services.
- **f.** Non-conformities between the figures and words of the Quoted Prices Sometimes, non-conformities/errors are also observed between the quoted prices in figures and that in words. The same is to be taken care of as indicated below:
 - a) If, in the price structure quoted for the required goods, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
 - **b)** If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
 - c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (a) and (b) above.
 - **d)** If there is such discrepancy in an offer, the same is to be conveyed to the tenderer with target date on the above lines and if the tenderer does not agree to the observation of the purchaser, the tender is liable to be ignored.

iv. Evaluation of Tenders

The tenders will be evaluated on the basis of specifications as given the tender document and unit rate of each item and total cost.

a) The Technical Bids will be evaluated based on the track record and past experience of the firm in providing similar manpower to Government/Semi-Government Agencies. The weightage for the technical evaluation shall be assigned as under:

b) The financial bids will be opened only of those bidders whose technical bids would be complete in all respects as per tender document and such bidders score a minimum of 50 marks in the technical evaluation. In the Financial Bids, if the service charge per person quoted is less than 5% of the basic minimum wages, the quotation will be rejected out rightly. Further, in case the same lowest rate is quoted by more than one eligible firm, the selection will be based on the marks obtained by them at the time of Technical Bid analysis.

The purchaser does not bind himself to accept the lowest or any other tender.

v.Award of Work

Within Seven (07) days of the receipt of notification of award from the Purchaser, the successful tenderer shall sign the contract agreement as given at Chapter 6 and furnish the specified performance security.

Chapter 2. Activity schedule and other requirements

15. Description of Service:

Description of service: Central Water Commission (CWC) has received deposit work for Preparation of Detailed Project Report (DPR) of 31 Irrigation schemes in Jharkhand from Government of Jharkhand. Out of the 31 Irrigation schemes 11 nos. of Irrigation schemes have been assigned to Planning Circle/P&I Division, Faridabad under Yamuna Basin Organisation, CWC, New Delhi. Hydro-meteorological observation is to be carried out at these H.O sites for Gauge, Discharge, and sample collection of silt and water quality including other meteorological parameters. Services required for observation of hydrological and meteorological parameters viz Gauge & Discharge observation, collection of Water Quality and Silt samples, collection and recording of rain gauge readings at H.O stations mentioned at Chapter 3 "Schedule of Requirements".

ii) Background of the Organisation and the Project:

Background of Organization-Central Water Commission is a premier Technical Organization of India in the field of Water Resources and is presently functioning as an attached office of the Ministry of Water Resources, River Development and Ganga Rejuvenation, Government of India. The Commission is entrusted with the general responsibilities of initiating, coordinating and furthering in consultation of the State Governments concerned, schemes for control, conservation and utilization of water resources throughout the country, for purpose of Flood Control, Irrigation, Navigation, Drinking Water Supply and Water Power Development.

The CWC has got deposit works from the Government of Jharkhand for preparation of Detailed Project Report (DPR) of Irrigation Reservoir Scheme in a time bound manner. To prepare DPR including assessing water availability, water quality and sediment assessment, hydro-meteorological observation and management of record of data is essentially required.

Purpose/Objectives of the Assignment: In order to start Hydrological Observation and data management, services of skilled persons is required at the Irrigation Schemes proposed in East and West Singhbhum District, Jharkhand. The details are enclosed as **Annexure-I**. The Data Entry of the collected data will be done at SDE office, CWC, Jamshedpur by the Data Entry Operator.

The very first step in preparation of DPR of any water resources project is to measure the resource i.e. water availability at different places and on different point of time. The proposal for hiring services of skilled persons for hydrological data observations at H.O stations and further entry of data into system will help in collecting daily data of Gauge, Discharge, Silt & Water Quality etc. The data collected from sites will act as basic input in design of water retaining structures etc.

The brief of work to be carried out by the hired staff is as given below.

- b. **Discharge observation** once daily in the morning starting at 0800 hrs (1st June, 2018 to Nov, 2018 and 1st June, 2019 to Nov, 2019)
- c. **Water quality-** Water sample collection- once during monsoon season 2018 and 2019.
- d. **Silt analysis** Silt sample collection daily hrs (1st June, 2018 to Nov, 2018 and 1st June, 2019 to Nov, 2019
- e. **Meteorological Parameter such as Rainfall, Temperature:** Daily from 1st June, 2018 to 31st Dec, 2019
- f. Entry of HO & Met data into proper record and other works at the site as per SDE/JE in-charge of the site etc.
- **B. Data Entry Staff:** Daily entry of observed data is to be done by the Data Entry Operator at SDE (Office) at Jamshedpur from 1st June, 2018 to 31st Dec, 2019.

Documents of Contract:

All the documents shall be considered as correlative, complementary and mutually explanatory. The contract shall be read as a whole for the interpretations. All correspondences, notices etc. shall form a part of the contract.

25. Agency responsibilities and Obligations

- a. The Agency/Contractor will abide by the job safety, insurance, customs and immigration measures prevalent and laws in force and will be liable to indemnify the Purchaser from all demands or responsibilities arising from accidents or loss of life, the cause of which is the Contractor's negligence. The Contractor will pay all indemnities arising from such incidents and will not hold the Purchaser responsible in any manner.
- b. The Agency/Contractor is responsible to conduct all contracted activities with due care and diligence, in accordance with the Contract and using state-of-the-art methods and economic principles and exercising all reasonable means to achieve the performance specified in the Contract.
- c. The Agency/Contractor is obliged to work closely with the Purchaser and abide by directives that are consistent with the terms of the Contract.
- d. The Agency/Contractor whose tender is accepted will be required to furnish:
 - i. Performance security
 - ii. Certificate of GST Registration.
 - iii. Photo copy of registration certificate.
 - iv. Photo copy of PAN
 - v. EPF Registration,
 - vi. ESI Registration,
 - vii. Any other document as required by the purchaser

26. Purchaser's responsibilities

- a. The purchaser will ensure accuracy of all information.
- b. The purchaser will ensure the availability of sites for the work.

27. Interpretations:

Language: Shall be English only for the purpose of this contract.

Context: The singular and plural shall be interchangeable as per the context of the contract.

28. Duration of contract:

The period of operation of the contract shall be from 1st June, 2018to 31stDec. 2019. The same may be extended up to 3 months at a time but not more than 6 months with mutual consent.

29. Programme of services:

The services will have to be started by the Agency/agencies from 1st June, 2018 to 31stDec. 2019 after award of contract at the locations as identified in the Chapter 3, Schedule A.

30. Confidentiality:

- a. The Agency shall not, without the Purchaser's prior written consent, disclose the Contract, or any provision thereof, or any specification or information furnished by or on behalf of the Purchaser in connection therewith, to any person other than a person employed by the Agency in the performance of the Contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- b. Any document, other than the Contract itself, shall remain the property of the Purchaser and all copies thereof shall be returned to the Purchaser on termination of the Contract.
- c. The Agency shall not, without the Purchaser's prior written consent, make use of any document or information enumerated in this document except for purpose of performing the Contract.
- d. The Purchaser shall not, without the Agency's prior written consent, disclose any documents, data or other information furnished by the Agency in connection with the Contract, and clearly identified in advance by the Agency as being confidential, to parties not directly involved in the project(s) covered by the Contract.

31. General Conditions of Contract:

- 1) Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by Government of India/ State Governments.
- 2) Incomplete tenders/tenders without specified EMD and cost of tender shall be rejected.
- 3) The bidder should not have been black listed by any Government or non-Government institutions or Government Department undertaking/public enterprises.
- 4) The Firms shall be registered in India with permanent office in India.
- 5) The Agency should have an experience in handling manpower in last three years having turnover Rs 1 Crore per year.
- 6) The competent authority on behalf of President of India does not bind itself to accept the lowest or any tender and reserves its right to reject or postponed any or all of the tenders received without the assignment of any reason. All tenders in whom any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to rejected.
- 7) Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the Agency who resort to canvassing will be liable to rejection.
- 8) Copies of other documents pertaining to the works will be open for inspection by the tenderers at the office of the above mentioned officer. Tenderer are advised to inspect and examine the site and its surrounding and satisfy them before submitting their tenders, the form and nature of the site, the means of access to the site and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tender shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. Submission of a tender by a tenderer implies that he has read this notice and all other documents and has made himself aware of the scope and specifications of the work to be done.
- 9) For bidding, bidder must have valid Digital Signature Certificate (DSC) and registered with e-tendering web portal of Telecommunications Consultants of India Limited (TCIL) as supplier.
- 10) Bidding only through e-procurement is acceptable under this contract.
- 11) This office shall not be liable for any financial or any other loss occur to bidder for bidding through TCIL portal due to any technical or administrative or any other reasons.
- 12) This office shall not be liable for any financial or any other loss occur to bidder due to cancellation of tendering process at any stage by this office.

32. Special Conditions of Contract:

- 1) The Agency shall provide manpower in taking hydrological observations and data entry and other services being carried out by P&I Division, CWC. The hydrological observation at Nalas/Streams/Rivers sites is taken as per the direction of CWC.
- 2) It is not allowed by the Tenderer to bid in Piece meal manner. Tenderer has to bid for all Hydrological Observation sites and other services as mentioned in the requirement.
- 3) The tenderer will have to deploy the required manpower for manpower services as and when the sites are made available by the purchaser. The payment for the services will be made as per the actual services provided.
- 4) The department will provide the necessary registers for record keeping. The Agency must enter the observed data in the register immediately after taking observation.
- 5) The observed data must not be revealed to any other person in any form.
- 6) Generally, one person at each discharge site will be from CWC who will assist the supervisor and the staff of the Agency to carry out the observation at the site. The CWC staff will guide and assist in taking hydrological observation of river/nala at site.
- 7) As per requirement, the manpower deployed at sites may be required to move to other sites/ offices/ places for any specific work. In this case they shall be treated on tour for which their engagement would be considered as 8 hrs per day and also would be entitled for daily allowances equivalent to Skilled Work Assistant (SWA) in case of Semi-Skilled and Data Entry Staff and equivalent to JE in case of Supervisor which would be paid to the agency only after the satisfaction of the purchaser.
- 8) The age of the deployed person should not be less than 18 years. The deployed person should fulfill the qualification criteria as mentioned under requirement.
- 9) The Agency shall change the staff in consultation of officer in-charge of CWC, if required.
- 10) CWC will not provide any residential facility to the Agency.
- 11) Transportation and accommodation arrangements of staff will be made by Agency at its own cost. The Agency shall be responsible of safety of its own staff.
- 12) CWC will provide all equipment required for hydrological observations. The safety of equipment during observation will be the responsibility of Agency. After data observation at discharge site, the Agency has to return the equipment back to CWC staff posted there.
- 13) The number of sites shown in tender document is approximate and this quantity may increase or decrease, even during contract period also, as per the requirements without any change in unit price or other terms and conditions.
- 14) The Agency has to withdraw such staff who are not found suitable by the office-in charge for any reasons immediately on receipt of such a request.
- 15) There is no Master and Servant relationship between the employees of the Agency and this office.

- 16) The Agency's person shall not claim any benefit/compensation/absorption/regularization of services from/in P&I Division,-CWC office under the provision of Industrial Disputes Act, 1947 or Contract Labor (Regulation & Abolition) Act, 1970. Undertaking from the persons to this effect shall be submitted by the Agency to this Department.
- 17) The Agency's personnel shall not divulge or disclose to any person, any details of office, operational process, technical know-how, security arrangements and administrative/ organizational matters as of confidential/secret nature.
- 18) The Agency's personnel should be polite, cordial, positive and efficient and follow official decorum and formal dress code while handling the assigned work. The Agency shall be responsible for any act of indiscipline on the part of persons deployed by them. The Agency shall be bound to prohibit and prevent any of their employees from being intoxicated while on duty, trespassing or acting in anyway detrimental or prejudicial to the interest of this Department. The decision of the Officer-in- charge on any matter arising under the clause shall be final and binding on the Agency.
- 19) The Agency shall be contactable at all times and messages sent by phone /e-mail/fax/ special messenger from CWC office shall be acknowledged immediately on receipt on the same day. The Agency shall strictly observe the instructions issued by the office in fulfillment of the contract from time to time.
- 20) This office shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the personnel of the Agency.
- 21) Escalation clause will not be accepted on any grounds during the period the contract is in force.
- 22) The service charges/rates quoted by the Agency shall be fixed for a period of contract and no request for any change/modification shall be entertained before expiry of the contract period. The Agency shall not assign, transfer or pledge the performance of services.
- 23) That on the expiry of the agreement as mentioned above, the Agency will withdraw all its personnel and clear their accounts by paying them all their legal dues. In case of any dispute on account of the termination of employment or non-employment by the personnel of the Agency, it shall be the entire responsibility of the Agency to pay and settle the same.
- 24) If at any stage, the agency is found to be involved in any unfair/ fraudulent practices or nonpayment of due amount as per rule to the deployed manpower and on verification by the purchaser, if any such allegation is found to be to true, the contract may be terminated at the discretion of the purchaser and the agency will be blacklisted. Any such due payment would be deducted from the running/final bill or performance security of the agency and would be paid to the concerned deployed persons.

- 25) Any dispute arising out of the contract shall be settled within the jurisdiction of Faridabad.
- 26) During monsoon season the necessary material such as umbrella, rain coat, gum boot, torch etc. need based to be provided by the Purchaser.
- 27) The staff to be deputed by the Agency should have skills of swimming in river. At least one person at each discharge site should have skill of rowing the boat in river.
- 28) The staff to be deputed by the Agency shall be physically and mentally fit.
- 29) The persons supplied by the Agency shall not have any Police records/criminal cases against them. The Agency should make adequate enquiries about the character and antecedents of the persons whom they are recommending. Before deployment, the character and antecedents of persons shall be verified by the Service Provider through local police, collecting proofs of residence, driving license, bank account details, previous work experience and recent photograph and a certification to this effect shall be submitted to this office. The service provider will also ensure that the personnel deployed are medically fit and will keep in record a certificate of their medical fitness.
- 30) The service provider's person shall not claim any benefit/compensation/absorption/regularization of services from/in this office under the provision of Industrial Disputes Act, 1947 or Contract Labor (Regulation & Abolition) Act, 1970. Undertaking from the persons to this effect shall be submitted by the service provider to this Department.
- 31) The service provider's personnel should be polite, cordial, positive, and efficient and follow official decorum and formal dress code while handling the assigned work. The service provider shall be responsible for any act of indiscipline on the part of persons deployed by them. The agency shall be bound to prohibit and prevent any of their employees from being intoxicated while on duty, trespassing, or acting in anyway detrimental or prejudicial to the interest of this Department. The decision of the Officerin- charge on any matter arising under the clause shall be final and binding on the agency.
- 32) That the persons engaged shall not interfere with the duties of the employees of this office.
- 33) The service provider has to provide Photo Identity Cards to the persons employed by him/her for carrying out the work. These cards are to be constantly displayed & their loss reported immediately.
- 34) The service provider shall ensure proper conduct of persons provided in office premises, and enforce prohibition of consumption of alcoholic drinks, paan, smoking and loitering without work.
- 35) No wage/remuneration will be paid to deployed persons for the days of absence from duty.
- 36) The service provider shall provide a substitute well in advance if there is any probability of any person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the service provider. The substitute shall be provided within 48 hours of purchaser intimating the agency.

- 37) In case of non-availability of worker because of sickness or any other reason, the service provider will provide his/her replacement to the satisfaction of the department on next working day.
- 38) The service provider shall be contactable at all times and messages sent by phone /e-mail/fax/ special messenger from this office shall be acknowledged immediately on receipt on the same day. The Service Provider shall strictly observe the instructions issued by the office in fulfillment of the contract from time to time.
- 39) The service provider shall not assign, transfer, pledge or sub contract the performance of services without the prior written consent of this office.
- 40) For different works minimum number of personnel shall be provided by the Agency as per norms as specified under Annexure-I.

33. Penalty:

- a) In case the supplier is unable to provide manpower services for hydrological observation, alternate arrangement will be made by the site-in-charge at the cost of Agency.
- b) Appropriate amount will be deducted from the payments due or performance security in case any loss is suffered by the department as per the contract.
- c) A penalty of Rs. 500 per day would be imposed in addition to deduction of proportionate manpower service charges for the day(s), if agency is not able to provide suitable manpower for reliable data to CWC. The penalty for initial 2(two) days may be waived off by Executive Engineer on genuine justification provided by the agency. If agency is not able to provide adequate manpower to CWC for a period more than 07 day, the Performance Security may be forfeited.

34. Loss of Property

The Agency shall indemnify and hold harmless the Purchaser and its employees from any losses, liabilities, and costs resulting from the death, personal injury, or loss to damage to the property, loss to the system arising due to the performance of contract.

35. Force Majeure:

- a. For purposes of this Clause, "Force Majeure" will mean an event beyond the control of the Agency and not involving the Agency's fault or negligence. Such events may include, but are not restricted to, wars or revolutions, fires, epidemics, quarantine restrictions, and freight embargoes. However, considering the nature of work rainfall and floods will not be considered as Force Majeure.
- b. If a Force Majeure situation arises, the Agency shall promptly notify the Purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Agency shall continue to perform its obligations under the contract as far as is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the force Majeure event.

- c. If an event of Force Majeure, continues for a period of ninety (90) days or more, the parties may by mutual agreement, terminate the Contract without either party incurring any further liabilities towards the other with respect to the Contract, other than to effect payment for Products already delivered or Services already performed.
- d. No claim or increased costs be entertained attributable to the Force Majeure's.

36. Contract Price:

Prices quoted by the tenderer shall be fixed during the tenderer's performance of the Contract and not subject to variation on any account and shall be inclusive of all taxes except GST. The prices for GST are to be quoted separately. The prices should be given as per the format given in price schedule.

37. Terms of Payment:

- a. The Agency will submit the bill in duplicate in respect of a particular month in the first week of the succeeding month to EE, Planning & Investigation Division, Faridabad. The payment will be released after submission of claim, complete in all respects such as dated certificate given by the Officer-in-Charge nominated by the Executive Engineer regarding production of documentary evidence towards manpower services of Hydrological Observations and other services.
- b. Deduction of tax at source (TDS) as per applicable rates prescribed under the Incometax Act, 1961, shall be made by the Executive Engineer, P & I Division, CWC, Faridabad from every payment made under this contract.
- c. The payment shall be made through e-payment. The agency shall provide proof of electronic payment made to deployed persons at the end of every completed quarter of the period of contract.
- d. GST would be deducted from the bill as per Government norms.
- e. The manpower required to move to other sites/ offices/ places would be entitled for daily allowances equivalent to Skilled Work Assistant (SWA) in case of Semi-Skilled and Data Entry Staff and equivalent to JE in case of Supervisor and Auto Cad/GIS Experts which would be paid to the agency only after the satisfaction of the purchaser.
- f. Payments to the Agency would be strictly on the basis of certification by the officer/site in charge that services are satisfactory.

38. Taxes and Duties:

GST/TDS shall be deducted at source as per the prevailing Government rules from time to time.

39. Advances:

No advance payment will be made by the Purchaser.

40. Release of Claims:

After completion of work and at the time of final payment the Agency shall give in writing, releasing the Purchaser for all the claims arising out of this contract other than specifically accepted in this contract.

41. Observance of Law:

- **a.** The contract shall be construed and operated as an Indian contract and as per Indian laws applicable from time to time.
- **b.** The parties to the contract shall protect and indemnify CWC against all claims or liabilities arising from the action of violation of all such laws.
- **c.** Agency shall observe all laws related to the man power services in terms of manpower of both Government of India and State Government of Jharkhand as applicable from time to time.
- **d.** The resultant contract will be interpreted under Indian laws.

42. Termination of Contract:

a. For Purchaser's convenience

The Purchaser can terminate the contract at any time by giving a notice of 30 days to the Agency. The Agency shall have no claim to any payment for the compensation or otherwise whatsoever on account of any profit or advantage which might have been derived.

b. For Agency's Default

- I. The Purchaser without prejudice to any other rights or remedies it may possess may terminate the contract
 - i. If the Agency becomes bankrupt or insolvent
 - ii. If the Agency has abandoned or repudiated the contract, persistently failed to carry out its obligations under this contract.
 - iii. If the Agency neglects its obligations under this contract.
 - iv. If the Agency has furnished any false document.
- II. The Purchaser may without prejudice to any other right issue a notice for termination of the contract stating the nature of default and requiring the remedy for the same. Failure of the Agency to carry out a specified work may be sufficient grounds for termination of the contract by the purchaser.

c. Termination by Agency

The Agency can terminate the contract with 30 days' notice only in case:

- i). The Agency is unable to carry out its obligations of the contract for any reason attributable to the Purchaser.
- ii). If the Agency fails to give one month's notice in writing for termination of the Agreement then one month's average payment and any amount due to the Agency from the office shall be forfeited.

d. On every termination

- I. The Agency shall cease further work.
- II. Under such circumstance, only the contract price properly attributable to the part of the work duly valued by the Purchaser shall be payable by the Purchaser to the Agency. The decision of the purchaser shall be final in this respect.

43. Liquidated Damages:

- a. If this office suffers any loss or damage on account of negligence, default or theft on the part of the employees/agents of the Agency, then the Agency shall be liable to reimburse to this office for the same.
- b. The Agency shall keep this office fully indemnified against the damage by any staff engaged by the Agency.
- c. For any accident or casualty occurred during the course of working to any staff deployed by the Agency, the liability that will arise out of the accident will be borne by the Agency. The responsibility will remain with the Agency and this office will in no way be responsible for it or any other clause mentioned above.
- d. Notwithstanding the provisions of tender document, the Agency shall not be liable for liquidated damages, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

44. Notices:

Notwithstanding anything stated otherwise, all notices of this contract shall be in writing through registered mail, speed post, personal or courier delivery. The transmission by electronic data exchange (fax, email) shall be reconfirmed in writing. Any change in the address etc. shall be communicated within 10 days to other party.

45. Disputes:

The decision of the Purchaser shall be final regarding the quality of man power services provided by the Agency, the other aspects arising shall only be referred as Disputes. The Agency may address its intention with evidences for the settlement of dispute in writing to the Purchaser. The work shall not stop, unless agreed mutually or ordered by the arbitrator(s).

46. Settlement of Disputes:

The settlement of all the disputes of any kind arising out of this contract shall be first through a Mediator and only after dissatisfaction with that, the (joint) Arbitrator(s) shall be appointed as per Arbitration & Conciliation Act 1996.
