3. Tender document can be downloaded from website www.eprocure.gov.in and www.cwc.nic.in from 10.00 hrs on 16/09/2020 to 15.00 hrs on 30/09/2020. However, the tender submitted by the Bidder will be opened only if following payment is made:

(i) Rs. 0/- in cash or through A/C payee Demand Draft (Non-Refundable) drawn on any scheduled commercial bank in favour of Deputy Director, RD, Directorate, CWC payable at New Delhi as Tender Fee.

(ii) Rs. 8000/- as Earnest Money Deposit (EMD) of tender through A/C payee Demand Draft (Refundable) drawn on any scheduled commercial bank in favour of Deputy Director, RD, Directorate, CWC payable at New Delhi or in the form of a Bank Guarantee (BG) from a Scheduled Commercial Bank as per Proforma at FORM I of Chapter 7 of this Tender document. In case the EMD is submitted in the form of the BG, it shall remain valid up to 45 days beyond the date of award of tender (tender validity period). The Public Sector Undertakings (PSUs) are exempted from furnishing EMD. The tenders unaccompanied by the EMD will be rejected summarily.

(ii) The Tender Fee and Earnest Money Deposit (EMD) have to be submitted before due date and time of opening of tender (i.e. at 15.30 hrs on 01/10/2020). However, the Micro and Small Enterprises (MSEs) shall be exempted from the requirement to submit the Tender Fee and EMD in pursuance of the Government of India's policy subject to the submission of the valid and authorized copy of certificate of registration as specified by the Ministry of MSME (MoMSME) like Udyog Aadhaar Acknowledgment/ Udyog Aadhaar Memorandum. In this context, it may be ensured that the nature of services mentioned in the MSE's certificate matches with the nature of services to be supplied as per Tender.

4. Tender forms completed in all respects should be submitted online only by 15.30 hrs. on 30/09/2020. Offline submission of tender and related documents is not permitted.

5. Technical bids of the tender will be opened online at 16.00 hrs. on 30/09/2020 in presence of the tenders/bidders who wish to see online opening of tender or offline through their authorized representative who may choose to attend online opening in this office. Time, place and other details of opening of financial bids will be intimated later.
