7. **Deposit of Bid value:** The successful bidder has to deposit bid security @ 25% of his bid money within 1 (one) working day of issue of notice of acceptance of the bid in the form of demand draft drawn from any scheduled bank guaranteed by Reserve Bank of India in favour of the **Executive Engineer, Bhutan Investigation Division, Central Water Commission payable at SBI, Hasimara**. He shall also inform his e-mail address to this office for conveying this notice of acceptance of the bid. Balance of the sale value shall be paid by him to this office in the form of demand draft drawn in favour of the **Executive Engineer, Bhutan Investigation Division, Central Water Commission payable at SBI, Hasimara** within 10 days of issue of acceptance letter e-mailed on the address given by him, and also sent by speed post.
8. In case of bidder's failure to deposit the bid security @ 25% of his bid money within the prescribed time, his earnest money shall stand forfeited. In case of failure to deposit the balance of the sale value within the time prescribed in para-7 above, the earnest money and bid security @ 25% of his bid money shall be forfeited. The defaulting bidder shall be debarred from participating in bidding in BID, CWC, Phuentsholing in future.
9. The auctioned materials must be removed within 3 working days from the date of payment of balance sale value, either in the presence of successful bidder or an agent duly authorized by him in writing on his behalf. He will leave the storage place of the materials neat and clean.
10. If the successful bidder fails to remove the materials within 3 working days as specified above, the balance materials lying at the site will be confiscated by the office of the Executive Engineer, Bhutan Investigation Division, Central water Commission, Phuentsholing, Bhutan.
11. The successful bidder would acquire lien on the auctioned materials after the payment of full bid money, and he will be responsible for any damage by way of pilferage, fire, or any natural calamity and no claim on this account shall be entertained.
12. The highest bid can be rejected without assigning any reason.
13. The Quotations received without any EMD will be summarily rejected.
