NOTICE INVITING TENDER(NIT)

On the behalf of the President of India, The Executive Engineer, P&I Division, Central Water Commission, Faridabad invites online Tenders on item rate basis from eligible contractors for the following work:

1. Name of work: "Repair work of Trolley Platform in Left Bank and existing approach staircase in Right Bank at Purnagiri GDS site under PHO Sub Division, CWC, Tanakpur, under Planning & Investigation Division, Faridabad"

Estimated Cost: Rs.5,82,100/-(Rupees Five Lakh Eighty Two Thousand One Hundred Only).

Period of Completion: 60 days from issue of letter of award of the work.

Sale of Tender: From 11.12.2021 (17:00 Hrs)

Online Submission of Bid: From 14.12.2021 (10:00 Hrs.) to 22.12.2021 (15:00 Hrs.)

Online Opening of Tender: 23.12.2021 (16:00 Hrs.)

2. Eligibility criteria:

- A. The Contractor should be registered with a valid registration certificate. Contactor should be registered with CPWD, MES, P.W.D, Railways, or other Government bodies/PSUs etc. or with any other reputed private agency or the vendor should be registered with valid registration credentials such as registration with state government or Govt. of India.
- B. The Contractor must have valid PAN and GST registration at the time of submission of bid.
- C. The Contractor must have executed work of similar nature in Central or State Government bodies/departments, Public Sector Undertakings, MES, Railways or for the reputed private departments in the last 7 years ending March 2021as per the value of each work as detailed below:
 - a) **Three** similar completed works costing not less than the amount equal to 40% of the estimated cost.

or

b) **Two** similar completed works costing not less than the amount equal to 60% of the estimated cost.

or

c) **One** similar completed work costing not less than the amount equal to 80% of the estimated cost.

Similar works means Civil works like RCC Construction, Earthwork, Erection and Masonry works, etc.

Completion certificates for the above should clearly indicate the scope and nature of work carried out and the value of various components of work as executed, in order to confirm conformity to

defined similar works. The completion certificate should be signed by the issuing authority with stamp without which the works will not be considered.

- 3. Average annual financial turnoverof Rs 5.80 Lakh in the previous 3 financial years (FY 2018-19, 2019-20 and 2020-21). For FY 2020-21, provisional / unaudited Certificate may also be submitted, provided the successful bidder has to submit the same within 15 days of award of work to avoid rejection of bid.
- **4.** Tender can also be freely downloaded from central procurement portal (www.eprocure.gov.in), and from www.cwc.gov.in.

EMD amount is exempted for all the bidders as per GoI OM No. F.9/4/2020-PPD, dated 12.11.2020. However, the bidder has to submit the "Bid Security Declaration" form as attached with this tender (page 45).

- **5.** Bids can be submitted only through online on Central Public Procurement Portal web site (www.eprocure.gov.in), as detailed under ITB (Instructions to bidders).
- 6. The bids will be opened online at the date mentioned in **Tender Data Sheet**, in presence of the bidders who wish to see the online opening of tender or offline through their authorized representative who may choose to attend online opening in the office of EE, Planning & Investigation Division, CWC, Faridabad-121001.
- 7. Bids shall be accepted through e-procurement only at e-tendering portal of CPPP.

Introduction:

Before submitting the tenders, the Tenderer/Bidder must ensure that he/she has understood the exact requirement of the said work and had a clear overview of location where work has to be executed. In case the Tenderer/Bidder wishes to get any point clarified with respect to the work or anything contained in this Tender Document, it is mandatory to raise the clarification in writing and in turn get it clarified from the *Executive Engineer, P&I Division, Central Water Commission, Faridabad (Department)* in writing as per the dates mentioned in the tender data sheet. In case no such clarification is raised by the Tenderer/Bidder, it will be construed that all the requirement of the *Department* are understood by the contractor. No communication in this regard shall be entertained at any stage of the work after opening of the tenders and during execution of thework.

Eligibility criteria:

i. Marking and submission oftenders:

Online Submission: The tenders should submit both "Technical bid duly signed & supporting document in respect of his eligibility for this tender" and "Financial Bid" online. The specifications should be same as given in this tender. Tenders must be submitted by the bidder online not later than the time and date specified in the NIT.

Online Submission:

No Hard copies of documents will be submitted by the bidder. Only online submission on the CPP portal will be accepted.

The Department may, at its discretion, extend this deadline for submission of tender by amending the tendering documents, in which case all rights and obligations of the Department and tenders previously subjected to the deadline will thereafter be subjected to the deadline as extended.

No tender may be withdrawn in the interval between the deadline for submission of tender and the expirations of the period of tender validity specified by the tenderer on the Tender Form. Withdrawal of a tender during this interval may result in the tenderer's forfeiture of its tender security.

ii. Opening ofBids

- 2. As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode/eMudhra etc.), with their profile.
- 5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.

- d. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- e. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. SCOPE OF WORK

This office operates and maintains number of Hydro-meteorological sites through its Sub-Division office located at Tanakpur, Uttarakhand titled "Pancheswar Hydrological Observation Sub-Division (PHO SD)". Under PHO Tanakpur Sub-Division, one of the Hydrological Site is located at Purnagiri around 25 kms from Tanakpur. Purnagiri is a Gauge Discharge Silt (GDS) observation Site located across Mahakali River where currently the discharge of the international boundary river is taken through manually operated Cable Way. The right bank of the river is the Indian Portion while the left bank lies in Nepal. At right bank lies the approach staircase for going down at the river bank from existing road and in the left bank (Nepal Side) lies the anchor pillar/ trolley winch platform of the cable way. During the recent heavy flood in Uttarakhand dated 19.10.2021, severe damages on the right bank (approach staircase, India Side) and left bank (Trolley Platform, Nepal Side) have been incurred. Since, Purnagiri is a very important site with respect to up-coming Pancheswar Multipurpose Project, there is an urgent need to carry out the remedial works on affected structures located on left and right of the International Mahakali River. The existing structures are constructed at both edges of Mahakali River at Purnagiri GDS site (Lat- 29°07'49', Long - 80°11'55''). The span of the river is in the range of 150m-200m at the desired location.

Thus, the present Scope of Work includes "Repair work of Trolley Platform where anchor pillar of cable way is positioned in Left Bank and existing approach staircase in Right Bank at Purnagiri GDS site under PHO Sub Division, CWC, Tanakpur, under Planning & Investigation Division, Faridabad". Photograph of existing site and drawings of the works are attached at Annexure-IA & I B respectively. The cross section of the river as on is attached at Annexure-IC.

Work at the Left Bank of the River (Nepal Side):-

There is an abutment on the left bank where Platformfor resting of Cable Trolley and its anchoring pillar has been constructed. As mentioned above, the abutment along with the platform has been damaged in recent flood at site (dated 19.10.2021) and the same needs to be repaired on urgent basis. Broad Remedial works include (i) Repairing of damaged masonry wall on the back side of Trolley Platform (ii) Plastering and Repairing Work of existing Trolley Platform (iii) Construction of masonry wall around trolley and (iv) Filling the crevices of weathered rocks beneath trolley platform with reinforced cement concrete.

Work at Right Bank of the River (India Side):-

On the Right Bank of the Mahakali River at Purnagiri GDS Site, staircases are constructed from road levels to bottom of River bank so as to read gauges at desired interval. During the recent flood, foundation material of staircase has been washed away at some portions leaving the structure in unsupported / hanging portion at the affected location. This staircase serves as the access path for reaching the river bank from existing road for taking gauge readings; hence the repair of this approach staircase is of utmost importance. Broad remedial works of staircase include filling rubble masonry beneath staircase area and their pointing work with cement mortar at the affected locations.

The above-mentioned work is to be done under the supervision of SDE PHO Sub Division, CWC, Tanakpur and all work shall be completed to his satisfaction.

The above Scope of Work shall be read in conjunction with Technical Specifications & Schedule of Quantities (Schedule-A) of this NIT for better clarity in understanding the scope of desired work.

Important Notes to Contractor for consideration:

- The above mentioned work is to be performed in both Banks of Mahakali River; the right bank of River is in India side and Left in Nepal side.
- Issuing of necessary permission for working in Nepal side shall be taken care of by Department as per requirement.
- For transportation of raw material like stone aggregate, sand, cement, steel etc. and labors from India side to Nepal side (and visa versa), existing cable way of Department may be used from 10:30 am to 06:00 pm. The time restriction of operation of Cable Way shall be noted. In general, it takes 30 minutes to cross the banks through the aforesaid cable way and the Contractor is advised to plan his work accordingly.
- The above cable way system is of manually operated type. Thus, operation of Cable Way shall be done by site staff /labour of contractor only. No staff of Department or material of any kind shall be provided to the Agency for operating the manual Cable Trolley from India to Nepal Side and vice versa.
- It is to be noted that the maximum load capacity of above cable way is 120 kg (including weight of person and material whole); hence, transportation of man-material may be planned accordingly.
- Department shall not provide any other type of services for transportation purposes (other than existing cable way system). However, if contractor desires to employ other means for transporting of labours and materials across the banks (like boat, raft etc.), the same can be done so under intimation to this Department. However, any charges incurred by the Contractor on purchase or hiring of boat, raft etc. shall not be borne/ reimbursed by the Department and the same shall be done at the sole concern and discretion of the contractor.
- The Contractor shall exercise utmost caution in executing the work on the both the banks and special care shall be taken by the Contractor while using the Department Manual Cable Way. Any losses to materials and untoward accidents to staff/ labour employed by the Contractor for the present work or while using cable wayshall not be borne by the Department under any circumstances and the responsibility of the same is the sole discretion of the contractor only.
- Nearest Railway station and Bus station to approach the Purnagiri GDS Site is Tanakpur Railway/Bus Station. However, the contractor is advised to visit the site before bidding so as to get proper idea of the location/area, road connectivity, labor availability etc. to understand the actual quantum of work to be executed and quote accordingly.
- The Bidder has to quote for both the works on the two banks of the River (i.e. work on both India and Nepal Side). Quoting of single work is prohibited and the bid of any bidder doing so shall be rejected and considered null and void.





















Plan of Staircase in Right Bank

- (i) The expression **works or work** shall, unless there be something either in the subject or context repugnant to such construction, be construed and taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent, and whether original, altered, substituted oradditional.

- b. The parties to the contract shall protect and indemnify each other against all claims or liabilities arising from the action of violation of all suchlaws.
- c. The contractor shall observe all the labour and mercantile laws which may all not be mentioned below but are pertinent to thiswork.

<u>Notices:</u> Not withstanding anything stated otherwise, all notices of this contract shall be in writing through registered post, speed post, personal or courier deliveries. The transmission by electronic data exchange (fax, email) shall be confirmed in writing. Any change in the address etc. shall be communicated within 10 days to the other party.

<u>Disputes:</u> The decision of the *Department* shall be final regarding the quality and progress of work, the other aspects arising out of the work shall only be referred as disputes. The contractor may address its intension with evidence for the settlement of dispute in writing to the *Department*. The work shall not stop, unless agreed mutually or ordered by thearbitrator(s).

<u>Settlement of Disputes:</u> The settlement of all the disputes of any kind arising out of the contract shall be first through a mediator and only after dissatisfaction with that, the (joint) Arbitrator(s) shall be appointed as per Arbitration & Conciliation Act 1996.

SPECIAL CONDITIONS OF CONTRACT

- 1. Technical & Financial bids should be address to Executive Engineer, P&I Division, CWC, Faridabad, and submitted online through e-procure web site before due date and time.
- 2. Tender shall remain valid for a period of 90 (ninety) days from the date of opening.
- 3. The Executive Engineer, PID, CWC, Faridabad does not bind itself to accept the lowest or any tender and reserves the right to accept or reject any or all the tenders either in whole or in part without assigning any reasons for doingso.
- 4. Each page of the Tender Documents is required to be signed by the person or persons submitting the tender in token of his/their having acquainted himself/themselves with the General Conditions of Contract, General Specifications, Special conditions etc. as laid down. Any tender with any of the documents not so signed will berejected.
- 5. The tender submitted on behalf of a 'firm shall be signed by all the partners of the firm or by a partner who has the necessary authority on behalf of the firm to enter into the proposed contract otherwise the tender is liable to berejected.
- 6. The tender form must be filled in English and all entries must be made by hand and written in ink. If any of the documents is missing, or unsigned the tender will be considered invalid
- 7. All erasures and alterations made while filling the tender must be attested by initials of the Tenderer. Overwriting of figures is not permitted; failure to comply with either of these conditions will render the tender void. No request for any change in rule or conditions after the opening of the tender will been entertained.
- 8. The contractor must not assign the contract. He must not subject any portion of the contract except with the written consent of the Employer failing which the Employer may serve a notice in writing rescinding the contract whereupon the security deposit shall stand forfeited and at absolute disposal of the Employer.
- 9. Tenderer must include in their rates, sales tax, excise duty, octroi, VAT, etc., on work contract and any other tax and duty levied by the Central Govt. or Local Body or any State Govt. if applicable. No claim in respect of any tax or levy shall be entertained by the Employer.
- 10. The successful tenderer is bound to carry out any items of work necessary for the completion of job even though such items are not included in the quantities and rates. Schedule of instructions in respect of such additional items and the quantities, if needed, will be issued in writing by the Employer.
- 11. Prices shall remain firm and free from variations due to rise and fall in the cost of materials, machines and labour or any other reasons whatsoever whether during the stipulated period of execution or during extended period of completion.
- 12. Rate quoted shall be valid for six months after virtual completion of above work and additional works as may be required may be undertaken on quoted rated by the firms. The firm shall be bound to undertake the same at their quoted rates up to six months after virtual completion of above work. This period may be further extended after mutual agreement by bothparties.
- 13. The agency shall aware themselves of the work before tendering.
- 14. The contractor shall bear all incidental charges for cartage, storage and safe custody of materials procured by the contractor and nothing extra shall be payable to the contractor on their accounts.
- 15. The full nomenclature of items shall be adopted in preparing abstract of final bill in the

- measurement book and also in the bill form for final bill.
- 16. Within 10 days of award of work, the agency shall submit the method statement as how he proposes to execute the work with quality and specification, sequencing of Items etc. for approval of Engineer-inCharge.
- 17. The contractor, through his engineer, shall ensure quality work in a planned and time bound manner. Any sub-standard Material/Work beyond set out tolerance limits shall be summarily rejected by the Engineer-in-Charge.
- 18. The work shall be executed as per the reports, documents, drawings provided by the Engineer –in- Charge. No claim for idle labour shall be entertained, nor, any claim on account of the delay in completion of the work shall beliable.
- 19. Contractor has to complete the work within 90 days from issue of letter of commencement.
- **20.** Contractor or his authorized representative should always be available at the office of Engineer In-charge for taking instructions etc. when called upon.
- 21. No payment will be made to the contractor for damage caused by rains, or other natural calamity during the execution of the works and no such claim on this account will be entertained.
- 22. Work: All work shall be supervised by the contractor including his duly authorized representatives. Contractor shall provide materials and workmanship to the best of their representative kind, and shall be fully responsible for executing the work as per prescribed specifications, latest BIS Codes of Practice and Drawings.
- 23. Issuing of necessary permission for working in Nepal side shall be taken care of by Departmentas per requirement.
- 24. For transportation of raw material like stone aggregate, sand, cement, steel etc. and labors from India side to Nepal side (and visa versa), existing cable way of Department may be used from 10:30 am to 06:00 pm. The time restriction of operation of Cable Way shall be noted. In general, it takes 30 minutes to cross the banks through the aforesaid cable way and the Contractor is advised to plan his work accordingly.
- 25. The above cable way system is of manually operated type. Thus, operation of Cable Way shall be done by site staff /labour of contractor only. No staff of Department or material of any kind shall be provided to the Agency for operating the manual Cable Trolley from India to Nepal Side and vice versa.
- 26. It is to be noted that the maximum load capacity of above cable way is 120 kg (including weight of person and material whole); hence, transportation of man-material may be planned accordingly.
- 27. Department shall not provide any other type of services for transportation purposes (other than existing cable way system). However, if contractor desires to employ other means for transporting of labours and materials across the banks (like boat, raft etc.), the same can be done so under intimation to this Department. However, any charges incurred by the Contractor on purchase or hiring of boat, raft etc. shall not be borne/ reimbursed by the Department and the same shall be done at the sole concern and discretion of the contractor.
- 28. The Contractor shall exercise utmost caution in executing the work on the both the banks and special care shall be taken by the Contractor while using the Department Manual Cable Way. Any losses to materials and untoward accidents to staff/ labour employed by the Contractor for the present work or while using cable way shall not be borne by the Department under any circumstances and the responsibility of the same is the sole discretion of the contractor only.
- 29. Nearest Railway station and Bus station to approach the Purnagiri GDS Site is Tanakpur

- Railway/Bus Station. However, the contractor is advised to visit the site before bidding so as to get proper idea of the location/area, road connectivity, labor availability etc. to understand the actual quantum of work to be executed and quote accordingly.
- **30.** The Bidder has to quote for both the works on the two banks of the River (i.e. work on both India and Nepal Side). Quoting of single work is prohibited and the bid of any bidder doing so shall be rejected and considered null and void.
- 31. The Engineer-in-Charge will examine the work executed from the point of view of scope of work and specifications for the various items before the work is finalized. If during any of the visit, use of sub-standard material or improper workmanship is noted by the Engineer-in-Charge or his superiors, the same shall also be promptly rectified on getting a written notice to doso.
- 32. No escalation shall be paid to the contractor beyond the quoted rates under any circumstances.
