

Subject : Controlling Officers for approval of Tour Programme and T.A. Bills.

In partial modification of the para '3' of Office Order No.4/2/2009-O&M/83 dated 19.01.2011(copy enclosed), it has been decided as under :-

I For Field Chief Engineers :-

A. With respect to SR 60,

- (i) The Chief Engineers, CWC will be their own Controlling Officers for the purpose of approving tour programme in respect of official tours to the places within their jurisdiction. A copy of the tour programme should be sent to the concerned Member and PPS to Chairman, before proceeding on tour.
- (ii) The concerned Member will be the Controlling Officer of the Chief Engineers for approving tour programmes in respect of official tours outside the jurisdiction of the Chief Engineer concerned.
- (iii) Chief Engineer, NWA shall get all his tour programmes approved by Chairman, CWC.

B. With respect to SR 191,

The Chief Engineers will continue to be their own Controlling officer for the purpose of counter signature on their TA bills.

II For Chief Engineers posted at CWC (HQ) :-

A. With respect to SR 60,

- (i) The concerned Member will be the Controlling Officer of the Chief Engineers to approve the official tour programmes.
- (ii) Chief Engineer (HRM) shall get all his official tour programmes approved by Chairman, CWC.

B. With respect to SR 191,

The Chief Engineers will continue to be their own Controlling officer for the purpose of counter signature to their TA bills.
