- $3\,$. The request of all other AD-IIs for transfer was also considered but could not be acceded to by the Competent Authority.
- 4. All the officers may be relieved immediately so as to ensure functional efficiency of the commission (except in cases where it is specifically indicated against their names).
- 5. Service Books of all the officials may be forwarded to the new place of posting after making all entries (Service verification entries including 25 years, CGEGIS, all leave

record including leave salary and pension contribution in respect of deputationist, order of relieving from the present place of posting etc.) at the earliest. Incomplete service Books received will be returned.

6. As per rule 20 of CCS (Conduct) Rules, no Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under Government. If anyone through himself/herself or through their relatives/friends brings political pressure for change of place of posting, disciplinary action will be initiated against him/her without any further notice/communication.
