- iii) The sealed quotation should be superscribed as "UPGRADATION OF COMPUTER AT SWRSD-I, CWC, TRIVANDRUM and should be addressed to the Executive Engineer, South Western Rivers Division, Central Water Commission, Jaldhara,D.No. 27/1927-A, Kasturba Nagar, P. O. Kadavanthara, Kochi – 682020.
- iv) The quotation must be in the form furnished by procuring entity and should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not the quotation will not be considered. Quotations written in pencil will not be considered.
