OFFICE MEMORANDUM

Sub.: Grant of 1st, 2nd and 3rd financial upgradation to AD-II/SDE, CWC.

I am directed refer to OM no. no. 26/1/2020-Estt.V/120-121 dt. 23.01.2020 wherein the SE (c) of various field offices were asked to forward the Check List of the AD-II whose MACP maturing for the period upto $31^{\rm st}$ March 2020 from their respective Offices. In this regard, it is stated that only 4 checklists had been forwarded. Further, due to prevailing COVID-19 crisis, the Meeting of the Department Screening Committee (DSC) for grant of $\S^{\rm t}$, $2^{\rm nd}$ and $3^{\rm rd}$ financial upgradation under MACPs, 2009 for the cases maturing upto 31.03.2020 could not be convened.

- 2. Now all up-gradation cases maturing up-to 30^{th} September, 2020 (tentative list enclosed) are proposed to be placed before the DSC for consideration. However, if any addition or deletion is required, the same may be informed in order to enable us to take up each eligible case and in case of addition the requisite information may be sent in prescribed proforma.
- 3. It is, therefore, requested that the information as asked in the enclosed check list in respect of all the eligible AD-II/SDE may be submitted to Estt.V Section, CWC by 22.6.2020 on through email **estt5@nic.in**. It is also requested that following documents should be attached with checklists:
- a) scanned copies of certified photocopies of relevant entries from service book like date of grant of 1^{st} / 2^{nd} financial upgradation, Major/minor penalty if any, extra ordinary leaves, Suspension period, dies non period etc..
 - b) Vigilance Clearance from field.

Checklists without such enclosures would not be considered. It may please be noted that in case the Check List is not received by the above date, the DSC Meeting shall be convened without considering the name of concerned candidate and recording the above fact, for which Estt. V Section shall not bear any responsibility.

- 4. All Chief Engineers/Superintending Engineers are requested to send the compiled Check List only in the enclosed prescribed proforma pertaining to the field units under their control via e-mail (Estt5@nic.in) only. Check list received from Chief Engineers/Superintending Engineers will only be entertained.
- 5. Further, in case the name of any eligible candidate had been left in previous DSCs, the checklist of the same may be sent to Estt V section via e-mail to Estt5@ nic.in.
