No. 1/6/2011-1R dated 15.04.2013 ([https://documents.doptcirculars.nic.in/D2/D02rti/1\\_6\\_2011-IR-10122013.pdf](https://documents.doptcirculars.nic.in/D2/D02rti/1_6_2011-IR-10122013.pdf)) issued by DoPT, Ministry of Personnel, Public Grievances & Pensions, New Delhi vide which guidelines have been issued for implementation of *suo-moto* disclosure under section 4 of the RTI Act, 2005. As per para 1.4.1, "**All Public Authorities shall proactively disclose RTI applications and appeals received and their responses, on the websites maintained by Public Authorities**".

In compliance of the above, It is requested that all Public Authorities (CPIOs) shall proactively disclose RTI applications, appeals and RTI replies on the websites maintained by them with search facility based on the keywords. In case, the websites of field offices are not operational, then the RTI and replies may be emailed to SM Dte for uploading on the website of CWC HQ.
