UPSC has decided to form a Panel of Assistant Supervisors/Invigilators for conducting of Union Public Service Commission's Civil Services (Preliminary) Examination at Delhi Centre which is scheduled to be held on 31st May, 2020. The aforesaid panel of officers will also be used for other examinations conducted by UPSC during the year 2020-2021.

2. Officers of the rank of Under Secretary or equivalent will be considered for Assistant Supervisors and Section Officers or Officers of equivalent rank and Group 'B' Non-Gazetted Officers will be considered by UPSC for appointment as Invigilators. A copy of the UPSC letter no. F.1/50/2019-EIA(CS)(110), dated 02nd January, 2020 is also enclosed.

3. In this regard, the Officers who are interested to get empanelled for Assistant Supervisors/Invigilators for the above exams may provide their particulars in the prescribed Proforma to E-IX section latest by 07.02.2020.

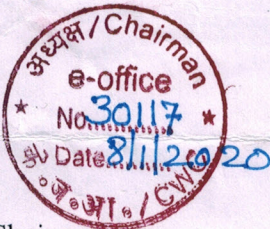

Subject: Formation of Panel of Assistant Supervisors/Invigilators for the conduct of the Union Public Service Commission's Examinations at Delhi Centre.

Sir/Madam,

I am directed to state that the Commission will hold the **CIVIL SERVICES (PRELIMINARY) EXAMINATION, 2020** on 31-05-2020 at 72 Centres including Delhi. For the examination to be held at Delhi sub-centres, services of a large number of Assistant Supervisors/Invigilators (over 4000) will be required. It has, therefore, been decided to prepare a panel of such officers who can be deputed as Assistant Supervisors/Invigilators for the ensuing examination. The aforesaid panel of officers will also be used for other examinations of the Commission during the year 2020-2021. The officers of the rank of Under Secretary or equivalent are eligible for inclusion in the panel of Assistant Supervisors. The Section Officers or officers of equivalent rank and group 'B' Non-gazetted officers will be considered for appointment as Invigilators. The Officers so appointed will be required to attend a briefing meeting for about an hour at the allotted venue (School where the examination will be held) on Saturday, 30th May, 2020 i.e. the day of arrangements.

2. For the Civil Services (Preliminary) Examination, each Assistant Supervisor and Invigilator will be paid remuneration of Rs. 1800/- (Rs. 1200/- for 31.05.2020 and Rs. 600/- for attending briefing meeting) and Rs. 1500/- (Rs. 1000/- for 31.05.2020 and Rs. 500/- for attending briefing meeting) respectively.

3. I am, accordingly requesting you to forward lists of gazetted and non gazetted Group-B officers, including lady officers, working in your Ministry/Department and Attached/Subordinate offices, whose services can be spared for examination at Delhi/New Delhi. As the matter is urgent, I am to request that the particulars of maximum officers for empanelment as Assistant Supervisors/Invigilators indicating their status may kindly be sent in the enclosed proforma to the undersigned latest by 7th February, 2020.
