\* As per clause 5 (6) of RRs of CWES (Group-A), where juniors who have competed their qualifying or the eligibility service on being Considered for promotion, their seniors shall also be considered provided they are not short of the requisite qualifying or the eligibility service by more than half of such qualifying or the eligibility service or two peers, Whichever is less.

## Note:

(1) As per Scheduled-II of RRs of CWES (Group-A), officers holding the post of Assistant Director- II or Sub-divisional Engineers in the pay band-2 Rs. 9300-34800 with grade pay of Rs. 4600 in the Central Water Engineering Group 'B' Service with five years' regular service in the grade are eligible for promotion to the Post in Junior Time Scale i.e. Assistant Director/Assistant Executive Engineer.

(2) No SC/ST Officer found in the extended zone of consideration

(3) No officer beyond Sl. No. 27 is eligible as per RRs of CWES.
