

2. No registration, transfer, road tax etc. In respect of the vehicle shall be payable by the Department.
3. Bidder should have valid GST registration, PAN etc.
4. The bidder should deposit Rs. 5000.00(Rupees Five Thousand Only) as EMD in a separate sealed envelope in the form of **A/C Payee Bank Draft** in the favour of "**Executive Engineer, P&I Division, CWC, Faridabad**". Without earnest money the bid shall be invalid & disqualified.

7. The cover/Envelope must be duly super scribed "For the auction of Ambassador No. DL3CJ-7479".
8. The delivery of the auctioned vehicle is to be taken within 20 days on the issue of letter of offer after making full payment thereof; otherwise the earnest money deposited will stand forfeited.
9. The undersigned may extend the period on justified and genuine grounds for 5 days on payment of demurrage charge of Rs. 100/- per day i.e. viable from the date of acceptance of the offer by the bidder.
10. GST as applicable will be charged extra from the successful bidders.
11. The undersigned will not entertain any claim for damage done by the way of theft, pilferage, fire or any other unforeseen calamity after realising full payment against the sale of auctioned vehicle.
