Following UDCs working in the Ministerial Cadre of Subordinate offices of CWC are in the zone of consideration for promotion to the Post of Assistant.

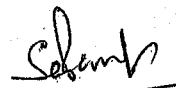

- 3) Vigilance Certificate regarding **suspension**.
- 4) Vigilance Certificate regarding any **administrative** action / **disciplinary** proceedings against the officer.
- 5) **Integrity** Certificate.
- 6) Certificate whether the official has submitted statement of immovable property return for the period ending 31-12-2019.
- 7) Details of previous place of posting since their appointment in CWC.
- 8) Details of personal foreign visit undertaken in the last three years.

It is also requested that concerned officers (Superintending Engineers / Executive Engineers) while certifying the vigilance certificate of above mentioned UDCs may specifically mention the dates below their signatures in the certificates.
